The President then made the following statement concerning the events of 25 October 2017:

STATEMENT FROM THE CHAIR

Under the circumstances, I feel an obligation to share my viewpoint on this matter.

In a free, democratic State, it is difficult to tolerate seeing a citizen arrested without charges being laid promptly.

An arrest is not a whim or a game. Its effect quickly takes on a public dimension and casts doubt on an individual's integrity.

Several years ago now, you chose me as your President, and you have unanimously expressed your confidence in me on two subsequent occasions.

Part of my role is to protect the rights and privileges of the Members of this Parliament. I am the guardian and defender of each Member's rights.

I, therefore, affirm that I find it intolerable that the police arrested a parliamentarian and, one week later, have brought no charges against him.

To do their work, parliamentarians need their freedom, with no restrictions. Regardless of the subjects of concern to them, including police work, they must be able to perform their duties serenely and with unmitigated peace of mind.

Police forces and their units must be accountable to their political authorities and to Parliament. If not, the risk of totalitarian abuses escalates.

I will fight for any one of you who might fall victim to intimidation. I see States where such things exist, but not here in Québec. At least, I hope I am not mistaken.

Today, a Member lost an important office, and his reputation was sullied. I think we must demand that the situation be clarified immediately.

Let charges be brought or public apologies be proferred: either accuse or excuse. If not, this Assembly will have to take steps to defend the very foundations of its existence, that is, liberty, justice and democracy.

Mr. Bonnardel, Second Opposition Group House Leader, requested a ruling on forwarding redacted documents to parliamentarians.

Motions Without Notice

Mr. Bérubé, Official Opposition House Leader, together with Mr. Spénard (Beauce-Nord), Mr. Khadir (Mercier), Mr. Lelièvre (Gaspé) and Mrs. Ouellet (Vachon), moved a motion to hold a parliamentary committee on the events that occurred on 25 October 2017; this motion could not be debated for want of unanimous consent.

Mr. Spénard (Beauce-Nord), together with Mr. Bérubé, Official Opposition House Leader, Mr. Khadir (Mercier), Mr. Lelièvre (Gaspé), Mr. Surprenant (Groulx) and Mrs. Ouellet (Vachon), moved a motion on appointing the Commissioner of the Unité permanente anticorruption; this motion could not be debated for want of unanimous consent.

Mrs. Ouellet (Vachon), together with Mr. Bergeron (Verchères), Mrs. Massé (Sainte-Marie-Saint-Jacques) and Mr. Lelièvre (Gaspé), moved a motion on the Assemblée parlementaire de la Francophonie and its President's call to support Catalan parliamentary institutions; this motion could not be debated for want of unanimous consent.
