Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Copeman (Notre-Dame-de-Grâce) and Mrs. Marois, Minister of Child and Family Welfare, jointly moved:

THAT, in the interest of Québec families, the National Assembly urgently ask:

- 1) The Government of Québec to do everything possible in order to resume negotiations on the parental insurance issue, with a view to reaching an agreement with the Government of Canada that would enable the establishment of a Québec programme that meets the needs of Québec families and that is financed in particular by means of a fair and equitable reduction in the contributions of Québec employers and workers to the employment insurance programme of the Government of Canada;
- 2) The Government of Canada to take part in good faith in these negotiations and to demonstrate more flexibility and openness towards the needs of Québec families and the primacy of Québec in the field of family policy.

By leave of the Assembly under Standing Order 84, a debate arose thereon.
