#### **Business Having Precedence**

#### *Estimates of Expenditure*

The Assembly entered upon a limited debate on the reports from the Committees that had considered the Estimates of Expenditure of the Ministries for the 2000-2001 fiscal year.

Before the debate began, Mr. Brouillet, Vice-President, announced the allocation of speaking time for the proceedings with respect to this limited debate: Five minutes shall be set aside for the independent Member; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group or by the independent Member may be redistributed, and individual addresses shall not otherwise be limited.

And debate arising on the reports from the Committees that had considered the Estimates of Expenditure for the 2000-2001 fiscal year;

By leave of the Assembly to set aside Standing Order 20, the proceedings continued beyond 12.00 o=clock p.m.

The debate being concluded and the Assembly having previously disposed of the want of confidence motions and the motion moved by the Minister of Finance upon conclusion of the Budget Speech, the question was put on the several reports together from the Committees that had considered the Estimates of Expenditure of the Ministries for the 2000-2001 fiscal year; a recorded division was thereupon demanded on these several reports together.

At the request of Mr. Brassard, Government House Leader, the division was deferred until Routine Proceedings on the present sitting day.

## **Estimates of Expenditure**

Mr. Landry, Minister of Finance, moved the introduction, passage in principle and passage of Bill 108, Appropriation Act No. 3, 2000-2001.

The question was put on this motion; a recorded division was thereupon demanded.

The motion was carried on the following vote:

Accordingly, Bill 108, Appropriation Act No. 3, 2000-2001, was passed.

### **Government Bills**

Report Stage

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 29, An Act to again amend the Taxation Act and other legislative provisions.

During the debate, by leave of the Assembly to set aside Standing Order 257, Mr. Bégin, Minister of Revenue, moved:

### 10 May 2000

THAT the references contained in the sections of Bill 29, An Act to again amend the Taxation Act and other legislative provisions, be amended in order to take into account the coming into force, on 1 May 2000, of the loose-leaf publication, updated as at 1 April 1999 and 1 November 1999 as regards Chapters D-17, I-2, I-3, I-4, L-3, M-31, R-20.1, T-0.1 and T-1 of the Revised Statutes of Québec (Order-in-Council 472-2000 of 12 April 2000).

This motion was carried.

And debate continuing on the consideration of the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 29;

The debate being concluded, the report was concurred in on division.

## Passage in Principle

Resuming the debate on the motion by Mrs. Marois, Minister of Health and Social Services, –That Bill 107, An Act to provide for balanced budgets in the public health and social services network, do now pass in principle;

Mr. Pinard, Vice-President, interrupted the debate to inform the Assembly that he had received a request for a debate upon adjournment to be held on Thursday, 11 May 2000, on a question by Mr. Mulcair (Chomedey) to Mr. Bégin, Minister of Revenue, about the *Act respecting the Ministère du Revenu*.

And debate continuing;

At 5.59 o'clock p.m., the debate on the motion by Mrs. Marois, Minister of Health and Social Services, was adjourned. Mr. Pinard, Vice-President, adjourned the Assembly until Thursday, 11 May 2000, at 10.00 o'clock a.m.
