#### Information on the Proceedings of the Assembly

Mr. Pinard, Vice-President, informed the Assembly that, following an agreement reached between the House leaders, the debate upon adjournment, requested at the sitting of 5 April 2000 and scheduled for today, between Mr. MacMillan (Papineau) and Mr. Julien, Minister for Industry and Trade, about the inequitable treatment of the Centredu Québec with respect to the fabrication of aluminium, will take place at the end of the sitting on Tuesday, 11 April 2000, and that this debate will not be included in the number of debates provided for in Standing Order 312.

He also informed the Assembly that on Friday, 14 April 2000, Mr. Dupuis (Saint-Laurent) would question Mr. Ménard, Minister of Public Security, during an interpellation on "the management of correctional services".

Mr. Brassard, Government House Leader, raised a point of order concerning the possibility of holding an interpellation during the consideration of the estimates of expenditure. Mr. Pinard, Vice-President, took the matter under advisement.
