THAT the National Assembly ask the Government of Québec and the Commission de la Capitale nationale to honour the memory of the Honourable Adélard Godbout by giving his name to a public building or to a thoroughfare of the Capital.

After debate thereon, the motion was carried and Bill 69 was accordingly passed in principle.

On motion by Mr. Brassard, Government House Leader, Bill 69 was referred for clause-byclause consideration to the Committee of the Whole.

Passage in Principle

Resuming the debate on the motion by Mr. Boulerice (Sainte-Marie—Saint-Jacques), —That Bill 195, An Act to amend the Act to establish Fondaction, le Fonds de développement de la Confédération des syndicats nationaux pour la coopération et l=emploi, do now pass in principle;

The debate being concluded, the motion was carried and Bill 195 was accordingly passed in principle.

On motion by Mr. Boulerice, Deputy Government House Leader, Bill 195 was referred for clause-by-clause consideration to the Committee on Public Finance, of which the Minister for Industry and Trade shall be a member during its deliberations in respect of the said Bill.

Mr. Boulerice (Sainte-Marie—Saint-Jacques) moved, —That Bill 196, An Act respecting the pension plan of the non-teaching staff of the Commission des écoles catholiques de Montréal, do now pass in principle.

After debate thereon, the motion was carried and Bill 196 was accordingly passed in principle.

On motion by Mr. Boulerice, Deputy Government House Leader, Bill 196 was referred for clause-by-clause consideration to the Committee on Public Finance, of which the Minister of State for Administration and the Public Service, Chairman of the Conseil du Trésor, shall be a member during its deliberations in respect of the said Bill.
