**Business Standing in the Name of Members in Opposition**

Mrs Dorion (Taschereau) moved:

THAT the National Assembly ask the Québec Government to confirm that

- 1) the structuring public transit network project for Québec City will be carried out as planned, without dividing it into parts or carrying it out in phases;
- 2) the project will be funded with federal funds, according to the agreed plan, as soon as possible; and
- 3) it will demand Québec's full and rightful share of funding for building green infrastructure throughout Québec.

Mrs. Soucy, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for her reply; 48 minutes 30 seconds to the parliamentary group forming the Government; 28 minutes 30 seconds to the parliamentary group forming the Official Opposition; 21 minutes 9 seconds to the Second Opposition Group; 8 minutes 51 seconds to the Third Opposition Group; and 1 minute 30 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 2 minutes. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

By striking out, in paragraph 2, the words “, according to the agreed plan,”;

By replacing, in paragraph 3, the word “demand” by the word “use”.
