#### **Motions Without Notice**

By leave of the Assembly to set aside Standing Order 185, Mr. Marissal (Rosemont), together with Mr. Tanguay (LaFontaine), Mrs. Hivon (Joliette), Mr. Ouellette (Chomedey) and Mrs. Fournier (Marie-Victorin), moved:

THAT the National Assembly recall that the Act respecting Access to documents held by public bodies and the Protection of personal information is, despite its imperfections, an access to information mechanism that is essential to Québec democracy;

THAT it recall that under that Act, all public bodies governed by the Act must send, in accordance with the provisions and deadlines set out therein, the information requested by a citizen who makes an application for access; THAT it remind all public bodies, in particular the Ministère de l'Éducation et de l'Enseignement supérieur, that compliance with this Act is not optional and that the necessary resources must be allocated to ensure the processing of applications for access, regardless of their subject matter.

> THAT the National Assembly honour the memory of the missing and murdered Indigenous women and girls and applaud the courage of the families who shared their experiences and their stories;

> THAT it recognize the importance of everyone working together as a society to fight acts of violence committed against the women and children of the First Nations and the Inuit of Québec;

> THAT the National Assembly recognize that the NIMMIWG has painted an overall portrait of the issues and has made recommendations as to the concrete and sustainable actions to be taken;

THAT it mention that the Québec Government is already taking action in collaboration with the First Nations and the Inuit to establish an action plan, as stipulated in the second recommendation of the Québec report;

THAT, lastly, it observe a minute of silence in memory of the Indigenous women and girls that went missing and were murdered.

The question was put on this motion, and a recorded division was thereupon demanded.

THAT it clearly reaffirm its willingness to reach new agreements and maintain the existing Nation-to-Nation ties, based on the respect, cooperation and esteem we all deserve;

THAT this day remind us that every person in Québec deserves to have the same rights, that we must maintain our collective efforts of reconciliation with Indigenous peoples, and that this rapprochement offers us an exceptional opportunity for enriching the cultural diversity of the peoples of Québec.

By leave of the Assembly, a debate arose thereon.

#### **Government Motions**

Mr. Jolin-Barrette, Government House Leader, moved:

THAT, pursuant to Standing Order 178, a select committee be established for the purpose of creating a portrait of the sexual exploitation of minors in Québec, including the consequences on the transition to adulthood and any other consideration that may enlighten committee members;.

THAT the name of this committee be "Select Committee on the Sexual Exploitation of Minors";

THAT the committee be composed of (13) members distributed as follows:

(7) Members from the parliamentary group forming the Government, including the committee chair;

(4) Members from the Official Opposition, including the committee vice-chair;

(1) Member from the Second Opposition Group;

(1) Member from the Third Opposition Group;

THAT each parliamentary group forward to the Director General of Parliamentary Affairs the list of its committee members, including the name of the chair and of the vice-chair, not later than seven days after this motion has been carried;

THAT the committee allow any independent Member to take part in its proceedings according to the terms set out in Standing Order 132;

THAT the committee's steering committee be composed of the chair, the vice-chair, one Member from the Second Opposition Group, one Member from the Third Opposition Group and the clerk;

THAT the committee hold special consultations and that it may hold public hearings and deliberative meetings as soon as this motion is carried;

THAT the committee may hold special consultations during deliberative meetings or in-camera meetings at the request of the witness;

THAT the committee may use video conferencing within the framework of hearings;

THAT the committee may organize upgrading training for its members;

THAT the committee may travel or meet in a place other than the precincts of the National Assembly;

THAT the steering committee determine the persons and organizations that the committee will hear;

THAT the steering committee of the committee determine the total length of each hearing as well as the length of each witness's presentation and exchanges with members of the committee;

THAT the organization of proceedings be entrusted to the committee's steering committee, including the preparation of the schedule according to any request for changes made by individuals and organizations;

THAT the committee be convened by its chair, pursuant to Standing Order 148, even if it is to consider an order of reference from the Assembly;

THAT the committee not be limited to three clear days, following special consultations, in which to hold deliberative meetings for the purpose of agreeing upon any observations, conclusions or recommendations that it wishes to include in its report;

THAT the committee table its report before the adjournment of the Fall 2020 proceedings;

THAT the rules pertaining to standing committees be observed in the committee insofar as they are not in variance with the provisions of this motion;

THAT the Committees Service ensure the necessary support for the smooth functioning of this committee;

THAT the committee have the resources needed to fulfill its mandate, particularly in terms of support for research and publicity.

A debate arose thereon.

At the end of his address, Mr. Benjamin (Viau) moved:

THAT the motion moved by the Government House Leader be amended as follows:

By replacing, in the third paragraph, number "13" by number "17" and number "7" by number "9";

By adding, at the end of the third paragraph, the following subparagraphs: "The Member for Chomedey;", "The Member for Marie-Victorin;";

By striking out the 5th paragraph.

The motion, as amended, would read as follows:

THAT, pursuant to Standing Order 178, a select committee be established for the purpose of creating a portrait of the sexual exploitation of minors in Québec, including the consequences on the transition to adulthood and any other consideration that may enlighten committee members;

THAT the name of this committee be "Select Committee on the Sexual Exploitation of Minors";

THAT the committee be composed of (17) members distributed as follows:

(9) Members from the parliamentary group forming the Government, including the committee chair;

(4) Members from the Official Opposition, including the committee vice-chair;

(1) Member from the Second Opposition Group;

(1) Member from the Third Opposition Group;

The Member for Chomedey;

The Member for Marie-Victorin;

THAT each parliamentary group forward to the Director General of Parliamentary Affairs the list of its committee members, including the name of the chair and of the vice-chair, not later than seven days after this motion has been carried;

THAT the committee's steering committee be composed of the chair, the vice-chair, one Member from the Second Opposition Group, one Member from the Third Opposition Group and the clerk;

THAT the committee hold special consultations and that it may hold public hearings and deliberative meetings as soon as this motion is carried;

THAT the committee may hold special consultations during deliberative meetings or in-camera meetings at the request of the witness;

THAT the committee may use video conferencing within the framework of hearings;

THAT the committee may organize upgrading training for its members;

THAT the committee may travel or meet in a place other than the precincts of the National Assembly;

THAT the steering committee shall determine the persons and organizations that the committee will hear;

THAT the steering committee of the committee determine the total length of each hearing as well as the length of each witness's presentation and exchanges with members of the committee;

THAT the organization of proceedings be entrusted to the committee's steering committee, including the preparation of the schedule according to any request for changes made by individuals and organizations; THAT the committee be convened by its chair, pursuant to Standing Order 148, even if it is to consider an order of reference from the Assembly;

THAT the committee not be limited to three clear days, following special consultations, in which to hold deliberative meetings for the purpose of agreeing upon any observations, conclusions or recommendations that it wishes to include in its report;

THAT the committee table its report before the adjournment of the 2020 Fall proceedings;

THAT the rules pertaining to standing committees be observed in the committee insofar as they are not in variance with the provisions of this motion;

THAT the Committees Service ensure the necessary support for the smooth functioning of this committee;

THAT the committee have the resources needed to fulfill its mandate, particularly in terms of support for research and publicity.

At 10.05 o'clock p.m., Mrs. Gaudreault, Third Vice-President, suspended the proceedings.

The proceedings resumed at 10.13 o'clock p.m.

The Assembly entered upon the debate on the amendment motion moved by Mr. Benjamin (Viau).

The question was put on the amendment motion, and a recorded division was thereupon demanded.
