**4.1.** Any body or person who intends to obtain a mandate or contract related to carrying out an information resource project of government-wide interest for which the use or release of personal information provided for in sections 3 and 4 applies must submit to an external audit aimed at ensuring compliance with the highest standards and best practices in matters of information security and protection of such information.

The Chair of the Conseil du trésor may determine the cases and circumstances in which the first paragraph does not apply.

**AMENDMENT:**

Replace by:

5. The Government may, for the purposes of section 3, prescribe special rules for the protection of personal information.

However, the Government must prescribe such special rules when, for the purposes of section 3, there is a high level of reasonable expectation of privacy, unless a provision of an Act or a regulation already provides for such protection.

“The rules prescribed under the second paragraph are to be published in the *Gazette officielle du Québec* within 15 days of their being prescribed.”

(5) a status report on the legislative amendments potentially required for implementation of the technological solution covered by the project.

“The Government must, in accordance with the criteria it establishes, provide for a consultation period, at the end of the period provided for in the preceding paragraph, to establish whether an implementation Act is necessary, and the Government publishes its conclusions within the next 30 days.”
