Complaints of Breach of Privilege or Contempt and Personal Explanations

By leave of the Assembly to set aside Standing Order 53, Mr. Lefebvre (Arthabaska) intervened on the point of privilege or contempt raised by Mr. Tanguay (LaFontaine) on 15 June 2019. The intervention concluded, Mr. Tanguay (LaFontaine) also made a few comments and informed the Chair that he considered the matter closed.

The President informed the Assembly that the point of privilege raised by the Member from LaFontaine was resolved.

16 June 2019

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

Pursuant to Standing Order 26.1, Mr. Jolin-Barrette, Government House Leader, moved:

THAT, to conclude consideration of Bill 21, An Act respecting the laicity of the State, the Assembly establish the exceptional legislative procedure provided for in Standing Orders 182 to 184.2 and 257.1 to 257.10;

THAT the President be permitted to suspend the proceedings at any time during the sitting at the request of a Minister or Deputy Government House Leader.

At 10.25 o'clock a.m., the President suspended the proceedings to allow the Members to examine the motions moved by Mr. Jolin-Barrette, Government House Leader.

The proceedings resumed at 10.44 o'clock a.m.

The President heard comments from Mr. Proulx, Official Opposition House Leader, on the receivability of the motion moved by Mr. Jolin-Barrette, Government House Leader.

16 June 2019

The President informed the Assembly that the motion moved by Mr. Jolin-Barrette, Government House Leader, was receivable.

Limited Debate

The President informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate on the reasons why the Assembly was summoned for extraordinary sittings and on the motion moved by the Government House Leader, namely on the motion to introduce an exceptional legislative procedure: 29 minutes 15 seconds to the parliamentary group forming the Government; 17 minutes 40 seconds to the parliamentary group forming the Official Opposition; 6 minutes 6 seconds to the Second Opposition Group; 5 minutes 29 seconds to the Third Opposition Group; and 45 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 1 minute. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was then put on the motion to introduce an exceptional legislative procedure, and a recorded division was thereupon demanded.

Government Bills

Committee of the Whole

Pursuant to the order just adopted, the Assembly resolved itself into a Committee of the Whole for clause-by-clause consideration of Bill 21, An Act respecting the laicity of the State.

The Committee of the Whole undertook clause-by-clause consideration of Bill 21.

16 June 2019

With the permission of Mr. Picard, Chair of the Committee of the Whole, Mr. Fortin (Pontiac) tabled the following:

A copy of excerpts from the *Charter of human rights and freedoms*.

Since the time allotted to the Committee of the Whole had elapsed, Bill 21, as amended, was thereupon reported.

At 5.36 o'clock p.m., Mrs. Gaudreault, Third Vice-President, suspended the proceedings.

The proceedings resumed at 7.38 o'clock p.m.

Report Stage

The Assembly took into consideration the report from the Committee of the Whole on its clause-by-clause consideration of Bill 21, An Act respecting the laicity of the State, together with the amendments transmitted by Mr. Jolin-Barrette, Minister of Immigration, Diversity and Inclusiveness, Mrs. David (Marguerite-Bourgeois), Mr. Zanetti (Jean-Lesage) and Mr. Bérubé, Leader of the Third Opposition Group.

The amendments transmitted by Mr. Jolin-Barrette, Minister of Immigration, Diversity and Inclusiveness, Mrs. David (Marguerite-Bourgeois), Mr. Zanetti (Jean-Lesage) and Mr. Bérubé, Leader of the Third Opposition Group, were declared in order, except the amendment submitted by Mrs. David (Marguerite-Bourgeois) to the title of the bill, which was declared out of order since parliamentary jurisprudence considers that the amendments under a bill are receivable only to the extent that they arise from those made to the sections of the bill.

16 June 2019

Mr. Picard, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 29 minutes 15 seconds to the parliamentary group forming the Government; 17 minutes 40 seconds to the parliamentary group forming the Official Opposition; 6 minutes 6 seconds to the Second Opposition Group; 5 minutes 29 seconds to the Third Opposition Group; and 45 seconds to each independent Member. However, if only one independent Member takes part in the debate, that Member's speaking time is 1 minute. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, Mrs. Soucy, Second Vice-President, put the question on the amendments.

Mr. Nadeau-Dubois (Gouin) Mr. Leduc (Hochelaga-Maisonneuve), Mr. Zanetti (Jean-Lesage), Mr. Fontecilla (Laurier-Dorion), Mrs. Ghazal (Mercier), Mr. Marissal (Rosemont), Mrs. Massé (Sainte-Marie–Saint-Jacques) and Mrs. Dorion (Taschereau) requested that their dissent be entered in the *Votes and Proceedings of the Assembly* with respect to the amendment introducing section 11.1 and the amendment to section 12 of the bill.

The amendments proposed by Mrs. David (Marguerite-Bourgeoys) on questions put severally thereon were negated.

The amendments proposed by Mr. Zanetti (Jean-Lesage) on questions put severally thereon were negated.

The amendments proposed by Mr. Bérubé, Leader of the Third Opposition Group, on questions put severally thereon were negated.

The amended sections, the sections of the bill that the Committee of the Whole had not disposed of, and the other components of Bill 21, on questions put severally thereon, were carried on division.

16 June 2019

The title of the bill, the motion to adjust the references contained in the bill, and the motion to renumber the bill, on questions put thereon, were carried on division.

The question was put on the report as amended, and a recorded division was thereupon demanded.

The amended report was concurred in on the following vote:
