The President issued a directive on a question raised by the Official Opposition House Leader on 18 September 2019, regarding comments made by the Minister of the Environment and the Fight Against Climate Change on Twitter relating to the Committee on Transportation and the Environment's report within the framework of the order of initiative on the recycling and local recovery of glass. Specifically, the Official Opposition House Leader charged that the Minister had interfered in the Committee's business.

RULING FROM THE CHAIR

The Committee on Transportation and the Environment adopted an order of initiative on 9 April 2019 to examine the recycling and local recovery of glass. Under that initiative, following consultations in August, the Committee was to report to the National Assembly no later than the third day after the resumption of proceedings in September 2019.

Within the framework of this mandate, the Committee members held a deliberative meeting on Tuesday, 17 September 2019, to discuss the observations, conclusions and recommendations to be made in the report. Following that meeting, a Member of the Official Opposition complained on Twitter that the Government was imposing a report void of content by refusing to allow the Committee members to do their work.

The next day, the Minister of the Environment and the Fight Against Climate Change responded on Twitter that the Committee had a deadline to complete its report with factual observations and recommendations.

Arguments on this matter broached the discussions among Committee members during the deliberative meeting to determine the report's observations, conclusions and recommendations. In this regard, the Standing Orders state that all committee meetings, except deliberative meetings, are public (S.O. 159). Conversely, deliberative meetings are held in private. This is not to say, however, that deliberative meetings are the same as in camera meetings whose status, within the meaning of the Standing Orders, renders all evidence heard, papers received or deliberations held confidential. Under parliamentary law, "in camera" has a very specific meaning, because disclosing any information obtained during in camera meetings can constitute contempt of Parliament. The meetings in question were not held in camera.

Nonetheless, deliberative meetings are not public, and the purpose of their private nature is to establish an environment in which Committee members may speak openly and frankly. The Chair relies on Committee members to conduct themselves in a manner that serves that purpose and asks that they measure the impact of their actions in public.

It should be noted that, when a committee adopts an order of initiative, no member of the Executive Council participates in its work. Only the committee's members may determine the content of the ensuing report.

Orders of initiative were introduced into the Standing Orders in 1984 to enhance the role of Parliament and its Members by giving them additional means to perform their duties more effectively and with greater independence vis-à-vis the Executive.

In light of that principle, the Minister of the Environment and the Fight Against Climate Change's tweet was ill-timed, because only the Committee could determine the content of its report and the time they should allow to find agreement on the report's observations, conclusions and recommendations.

Members of the Executive should not make comments that might hinder the independence of the Assembly and of its committees, since it is a matter of respect for the separation of powers.

Oral Questions and Answers

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Health and Social Services on its clause-by-clause consideration of Bill 2, An Act to tighten the regulation of cannabis, together with the amendments transmitted by Mr. Carmant, Minister for Health and Social Services, and Mr. Fortin (Pontiac).

The amendments were declared in order.

A debate arose thereon.

At 1.00 o'clock p.m., Mrs. Gaudreault, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

The Assembly continued the debate on consideration of the report from the Committee on Health and Social Services on its clause-by-clause consideration of Bill 2, An Act to tighten the regulation of cannabis, together with the amendments transmitted by Mr. Carmant, Minister for Health and Social Services, and Mr. Fortin (Pontiac).

The debate being concluded, Mr. Picard, First Vice-President, put the question on the amendments.

19 September 2019

At 3.15 o'clock p.m., Mr. Picard, First Vice-President, suspended the proceedings for a few minutes.

The proceedings resumed at 3.18 o'clock p.m.

Following a meeting with the House leaders, Mr. Picard, First Vice-President, informed the Assembly that it was agreed that the question would be put on the amendments of Mr. Fortin (Pontiac) severally.

The question was put on the first amendment to section 1 proposed by Mr. Fortin (Pontiac), and a recorded division was thereupon demanded.

At the request of Mr. Caire, Deputy Government House Leader, the divisions on the amendments proposed by Mr. Fortin (Pontiac) and Mr. Carmant, Minister for Health and Social Services, and on the report from the Committee on Health and Social Services were deferred until Routine Proceedings on the next sitting day.

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 18 September 2019, on the motion moved by Mr. Dubé, Minister Responsible for Government Administration and Chair of the Conseil du trésor, that Bill 23, An Act respecting the names and responsibilities of certain ministers and government departments and to enact the Act respecting the Ministère des Forêts, de la Faune et des Parcs, do now pass in principle.

After debate thereon, the motion was carried on division, and Bill 23 was accordingly passed in principle.

Mr. Caire, Deputy Government House Leader, moved that Bill 23 be referred to the Committee on Public Finance for clause-by-clause consideration.

The motion was carried.

19 September 2019

Passage in Principle

Mrs. Proulx, Minister of Tourism, moved that Bill 15, An Act respecting the Société de développement et de mise en valeur du Parc olympique, do now pass in principle.

After debate thereon, the motion was carried, and Bill 15 was accordingly passed in principle.

Mr. Caire, Deputy Government House Leader, moved that Bill 15 be referred to the Committee on Labour and the Economy for clause-by-clause consideration.

The motion was carried.

Passage in Principle

Mrs. LeBel, Minister of Justice, moved that Bill 29, An Act to amend the Professional Code and other provisions in particular in the oral health and the applied sciences sectors, do now pass in principle.

A debate arose thereon.

Debates upon Adjournment

At 6.00 o'clock p.m., the Assembly held three debates upon adjournment:

- the first, on a question from Mrs. Rizqy (Saint-Laurent) to Mr. Roberge, Minister of Education and Higher Education, about the CAQ Government's improvisation with regard to pre-kindergarten and its poor assessment of the cost of the classes;

19 September 2019

- the second, on a question from Mr. Fortin (Pontiac) to Mrs. McCann, Minister of Health and Social Services, about the CAQ Government's backpedalling on its promise to reduce hospital parking prices. Mr. Bonnardel, Minister of Transport, replaced the Minister for this debate;

- the third, on a question from Mr. Barrette (La Pinière) to Mr. Bonnardel, Minister of Transport, about the CAQ Government's lack of transparency as regards the 3rd link issue.

At 6.34 o'clock p.m., Mrs. Gaudreault, Third Vice-President, adjourned the Assembly until Tuesday, 24 September 2019, at 1.40 o'clock p.m.
