Motion moved by the Member for Maurice-Richard under Standing Order 97:

THAT the National Assembly solemnly reiterate that Anticosti Island is a natural jewel which is home to a geological and palaeontological heritage with exceptional universal value that is recognized worldwide;

THAT it recall that, in the past, all oil and gas exploration rights were bought back by the State to preserve the Island's singular beauty and heritage;

THAT it recall that, following a request made by the Québec Government in 2017, the federal government put Anticosti Island on Canada's Tentative List for World Heritage Sites and that this is the preliminary step for official nomination for inscription on UNESCO's World Heritage List;

THAT it recognize that the Ministère de la Forêt, de la Faune et des Parcs has, on many occasions, submitted recommendations opposing the creation of a buffer strip to protect the island's banks;

THAT, lastly, the National Assembly ask the CAQ Government to establish a buffer strip to protect the island's banks without delay and to formally commit to protecting Anticosti Island, preserving its exceptional natural features and supporting its nomination for inscription on the UNESCO World Heritage List by taking the necessary measures.

- 90) Mrs. Lessard-Therrien (Rouyn-Noranda–Témiscamingue) – **24 October 2019**
To the Minister of Transport

Route 117, which links Montréal to Rouyn-Noranda, is one of the deadliest highways in Québec. According to public data, at least 8 people lost their lives in fatal collisions in 2018, and 7 of the deaths were due to accidents in the Abitibi-Témiscamingue area alone. It was Route 117's heaviest toll since 2012. During the last election campaign, the CAQ assured us that improving the safety of the section of the 117 connecting Val-d'Or and Rouyn-Noranda would be one of its Government's priorities. Over a year has gone by since the election, but there has still been no plan or measure announced by the Québec government to make good on that promise.

More recently, the Minister Responsible for the Abitibi-Témiscamingue Region and the Nord-du-Québec Region even suggested that it was in fact the federal government's responsibility to finance future safety work on Route 117, since it is part of the Trans-Canada Highway network. The Government is perfectly aware that the federal level will not intervene in the Québec highway network unless the provincial authorities expressly request it to do so and that such a request would have to take the form of applying for funding from Infrastructure Canada. Until the Government of Québec submits an application, no funding

from the Canadian government will miraculously fall into the coffers of the Québec State.

My questions to the Minister of Transport are the following:

- What is the Government's plan to improve safety on the section of Route 117 between Val-d'Or and Rouyn-Noranda?
- Since the Government now seems to claim that it is the federal level's responsibility to finance work on Route 117, has the Minister of Transport submitted official funding applications to the federal government, for example, through Infrastructure Canada, to obtain the funds necessary to make that section safe?
- If so, on what date did the Minister submit that application and to which federal body was it submitted?
