By leave of the Assembly to set aside Standing Order 185, Ms. Nichols (Vaudreuil), together with Mr. Roberge, Minister of Education and Higher Education, Ms. Dorion (Taschereau), Mr. Arseneau (Îles-de-la-Madeleine) and Ms. Fournier (Marie-Victorin), moved:

THAT the National Assembly mark the 100th anniversary of the birth of the late Paul Gérin-Lajoie, proud Member for Vaudreuil-Soulanges from 1960 to 1969, and applaud his contributions to Québec's democratic life as the first person to head the Ministère de l'Éducation and as the foundational architect of the doctrine behind the external extension of Québec's internal jurisdictions through international relations, as well as the Fondation Paul Gérin-Lajoie's positive impact in the areas of literacy and international cooperation.

Pursuant to the order adopted on 10 March 2020, the Assembly resolved itself into a Committee of the Whole.

Consideration in Committee of the Whole

The Committee of the Whole entered upon consideration of Interim Supply for the 2020–2021 fiscal year.

At 1.00 o'clock p.m., Ms. Soucy, Second Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

The Committee of the Whole continued its consideration of Interim Supply for the 2020-2021 fiscal year.

With the permission of Mr. Picard, First Vice-President, Mr. Fortin (Pontiac) tabled the following:

The consideration being concluded, the question was put on concurrence in Interim Supply for the year 2020–2021.

At 7.05 o'clock p.m., Mr. Picard, First Vice-President, suspended the proceedings.

The proceedings resumed at 9.01 o'clock p.m.

Mr. Picard, First Vice-President, ruled on putting the question on Interim Supply for the year 2020–2021.

RULING FROM THE CHAIR

The Chair has taken the time to analyze what occurred when the question was put on concurrence in Interim Supply after the five-hour discussion before the Committee of the Whole and to review the video of the sequence of events several times. When the question was put on concurrence in Interim Supply for the 2020–2021 fiscal year, some Members said "approve", some said "negative", and others said "on division".

The Chair then ruled, in accordance with parliamentary tradition, that there had been concurrence on division, since the Government seemed to be in majority in the House.

The situation in the Assembly was not as plain as it was on 7 November 2019, when there was clearly a greater number of Opposition Members than Government Members at the time the question was put on a motion debated during Business Standing in the Name of Members in Opposition. On that day, the motion moved by the Official Opposition was declared carried, despite the opposition of the parliamentary group forming the Government.

In a Committee of the Whole, Members may enter or leave the Assembly Chamber up to the moment a recorded division is held. In the case at hand, the presence of a large number of public servants in the Chamber at the time the question was put certainly could have had an impact on the impression of the number of Government Members present. Moreover, there was some confusion owing to the large number of public servants and political staff in the Chamber and the fact that the difference in number between the Members in favour and those against was not obvious. Furthermore, some Members had left the Chamber and others had entered, as had various members of personnel, thereby making it difficult to obtain a clear tally of the division.

In light of this and given this special situation, the only way to obtain a clear result on the question is to hold a recorded division, as the Deputy Government House Leader has requested.

The motion was carried on the following vote:
