By leave of the Assembly to set aside Standing Order 185, Ms. Massé, Leader of the Second Opposition Group, together with Mr. Legault, Premier, Ms. Anglade, Leader of the Official Opposition, Mr. Bérubé, Leader of the Third Opposition Group, and Ms. Fournier (Marie-Victorin), moved:

THAT the National Assembly mark the 25th anniversary of the Bread and Roses Women's March Against Poverty, which took place from 26 May to 4 June 1995;

THAT it salute the commitment and contribution of the thousands of women marchers, participants, organizers and donors who carried out this unprecedented feminist event, which led to gains in equality and justice for all women, with an increase in the minimum wage, the automatic collection of support payments, the reduction in women immigrants' sponsorship period and a pay equity act;

THAT it recall that, despite the progress made since 1995, too many women still live in precarious conditions, poverty and exclusion;

THAT it recognize that it is predominantly women who are working with devotion in essential businesses and services, often in difficult conditions, as we are reminded by the COVID-19 crisis;

#### Information on the Proceedings of the Assembly

Ms. Soucy, Second Vice-President, informed the Assembly that on Wednesday, 27 May 2020, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Ms. Rizqy (Saint-Laurent).

The motion reads as follows:

THAT the National Assembly recognize that the confinement due to the COVID-19 pandemic has had a profound impact on the daily lives of Québec students;

THAT it acknowledge that the continuation of schooling and educational activities through remote means was carried out unevenly and that not all students received the same level of services;

THAT it acknowledge that the most vulnerable students may fall behind considerably and lose some of their educational gains;

THAT it recall that, according to many experts, anxiety levels have risen significantly among Québec's young people;

THAT it ask the Québec Government to provide Québec students with access to support services, such as psychological, speech therapy and special education services, throughout the summer in preparation for the beginning of the 2020–2021 school year, and that those services be offered on a continuing basis from now on;

THAT, lastly, it ask the Québec Government to establish a voluntary three-week upgrading period for all students, giving priority to students graduating from the elementary level to the secondary level and from the secondary level to the college level, so that they are able to fully acquire the learning likely to promote their school success and ensure a better transition.

- the second, on a question from Ms. Sauvé (Fabre) to Ms. Blais, Minister Responsible for Seniors and Informal Caregivers, about the disgraceful living conditions of some of the seniors currently in confinement;
- the third, on a question from Ms. Rizqy (Saint-Laurent) to Mr. Roberge, Minister of Education and Higher Education, about the services Québec students require to avoid losing some of their educational gains and the need to consult experts on this issue.

Mr. Roberge, Minister of Education and Higher Education, moved the adjournment of the Assembly until Wednesday, 27 May 2020 at 9.40 o'clock a.m.
