The Assembly was called to order at 9.40 o'clock a.m.

THAT the National Assembly mark the *Semaine des services de garde éducatifs à l'enfance*, which is held from 24 to 30 May and whose theme this year is *Une enfance sans limites*, That it applaud the network's flexibility during this time, in particular the fast and efficient putting in place of emergency childcare services:

THAT it commend the commitment and work of all network staff, from educators to managers, and the coordinating offices as well as the employees of the Ministère de la Famille;

THAT it recognize the huge positive impact that all these people have on Québec families and on their children. Every day, hundreds of thousands of parents entrust their children to their care, confident that they will be treated with affection and professionalism and a firm hand;

THAT, lastly, the Assembly join me in thanking all of the people who work in childcare services and who, day after day, prove that Québec has the world's best childcare services network.

By leave of the Assembly to set aside Standing Order 185, Ms. Melançon (Verdun), together with Ms. Labrie (Sherbrooke), Ms. Hivon (Joliette), Mr. Ouellette (Chomedey) and Ms. Fournier (Marie-Victorin), moved:

THAT the National Assembly take note of the recommendations contained in the coroner's report concerning the death of Ms. Daphné Huard-Boudreault, who was murdered on 22 March 2017 by her former spouse;

THAT it recognize that domestic violence is still rampant in Québec and that concrete, broad-based action is required to stem this societal scourge, in particular to prevent additional murders;

THAT it ask the Minister of Public Security to ensure that all police forces work with experts in the field to develop continuing education workshops, and make it mandatory for police officers to attend them in order to help them better detect domestic violence:

THAT it acknowledge that the support resources, housing resources and their outreach services for women who are victims of domestic violence are essential but underfunded and do not adequately meet victims' protection, accompaniment and prevention needs;

THAT it ask the Government to act on the report's recommendations as soon as possible and to deploy the necessary measures and funding to prevent new cases of femicide in Québec.
