The Assembly proceeded to Oral Question Period.

### Motions Without Notice

Mr. Birnbaum (D'Arcy-McGee), together with Ms. Massé, Leader of the Second Opposition Group, Mr. Bérubé, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey) and Ms. Fournier (Marie-Victorin), moved a motion concerning indigenous communities; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Fontecilla (Laurier-Dorion), together with Ms. LeBel, Minister of Justice, Mr. Derraji (Nelligan), Ms. Perry Mélançon (Gaspé), Mr. Ouellette (Chomedey) and Ms. Fournier (Marie-Victorin), moved:

THAT the National Assembly take note of the statistics contained in the most recent 3-year report of the Commission des droits de la personne et des droits de la jeunesse on the carrying out of the *Act respecting equal access to employment in public bodies*, which revealed that 26,307 more visible minority employees should be working in the public sector for it to be truly representative of the Québec population;

THAT it recall the motion carried unanimously on 2 June 2020 recognizing that racism exists in Québec and asking that a plan to fight racism be tabled as quickly as possible;

THAT it recognize that better ethnocultural representation in the public sector would contribute toward harmonious coexistence;

THAT it recognize that as Québec's largest employer, the Québec Government should be exemplary in this matter;

THAT the National Assembly ask the Québec Government to include strong, pragmatic measures in its plan to fight racism and discrimination so that the public sector can catch up in terms of ethnocultural minority representativeness as quickly as possible.

THAT the National Assembly affirm its intention to establish parental leave for MNAs and to ensure that this principle be recognized in the *Act respecting the conditions of employment and the pension plan of the Members of the National Assembly* as well as in the *Code of ethics and conduct of the Members of the National Assembly*;

THAT the Office of the National Assembly entrust responsibility for determining the specific process to the independent committee that determines the working conditions of MNAs, which must make this mandate a priority in order so it may be put in place by December 2020 at the latest.

THAT the National Assembly mark Quebec Fatherhood Week, running from 15 to 21 June and whose theme for 2020 is “Together, let’s keep dads involved”;

THAT it recognize that it is essential to promote as a social norm the fact that fathers can fully carry out their role in order to foster the optimal development of children and the well-being of family members with a view to co-parenting and gender equality;

THAT the National Assembly invite all employers to adopt work-family balance measures to encourage the involvement of all parents, both mothers and fathers, in family life;

THAT it recognize that fully assuming the role of fatherhood in 2020 can also mean embracing the message of feminists;

THAT the Assembly pay tribute to fathers, whether they are a single parent, in a relationship with another person or part of a blended family, regardless of their sexual orientation;

THAT it recognize that Québec dads are positive, inspiring role models for their children and that they strive to guide their children's daily learning so they will grow up to be engaged, responsible citizens and, perhaps one day, fathers and mothers themselves;

THAT, lastly, the National Assembly add its voice to mine, and to the voices of all Québec spouses and children in saying a huge "THANK YOU" to all our dads!
