Moment of reflection

Mr. Jolin-Barrette, Government House Leader, moved:

Common Provision

THAT the following terms and conditions be applicable exclusively to all the regular sittings of the Assembly and meetings of certain parliamentary committees that are to be held between 19 October 2020 and 11 December 2020;

Sittings of the Assembly

General Provisions

THAT the Assembly sit with a reduced number of Members in order to comply with physical distancing measures in line with public health recommendations, according to the following distribution:

- No more than 20 Members from the parliamentary group forming the Government;
- No more than 8 Members from the parliamentary group forming the Official Opposition;
- No more than 3 Members from the Second Opposition Group;
- No more than 3 Members from the Third Opposition Group;
- No more than 2 independent Members;

THAT, for the purposes of the Routine Proceedings, the distribution be modified to increase the number of Members from the Official Opposition from 8 to 10, the number of Members from the Second Opposition Group and the Third Opposition Group from 3 to 4, and to reduce the number of Members from the parliamentary group forming the Government by as many as those added to the other groups;

THAT, during any given period of Routine Proceedings, a Member from the Second Opposition Group be entitled to fill in for a first absent independent Member and a Member from the parliamentary group forming the Government be entitled to fill in for a second absent independent Member;

20 October 2020

THAT the independent Members indicate to the House Secretariat and the House Leaders of the parliamentary groups, not later than Monday, 6:00 p.m., which periods of Routine Proceedings they wish to take part in that week;

THAT, not later than 6:00 p.m. on the evening preceding a sitting, the Government House Leader communicate to the opposition groups a preliminary list of the ministers who will be present during Oral Questions and Answers the following day;

THAT ministers be able to participate in the Oral Questions and Answers period in two groups, one being present during Tuesday and Thursday sittings and the other during Wednesday sittings as well as Friday sittings during a period of extended hours of meeting;

THAT every Member be entitled to take the floor and to vote from a seat that is not the one assigned to him or her;

Recorded Division

THAT all questions be put in accordance with the procedure for recorded divisions;

THAT, for that purpose, the vote of the House Leader or the Deputy House Leader of a parliamentary group or, where applicable, of a Member whose name was notified by the latter to the Secretariat beforehand, is valid for all Members from his or her group;

THAT a Member be entitled to individually record a vote that differs from the vote of his or her parliamentary group or choose not to vote;

THAT the Member, if present, express such an intention immediately after the vote of his or her parliamentary group; and, if not present, inform the House Leader of his or her parliamentary group of such an intention so that the latter may notify the President during the taking of the division or notify the President in writing before the division is taken;

20 October 2020

THAT, unless they indicate otherwise, the vice-presidents do not vote in a recorded division;

THAT the names of all the Members having voted be recorded in the *Votes and Proceedings* of the sitting;

THAT all questions within the framework of a Committee of the Whole be put in accordance with this same procedure;

THAT, if an independent Member is absent, the Government House Leader be authorized to record the Member's vote regarding a stage in the consideration of a bill according to the instructions transmitted to the Government House Leader, if applicable;

Suspension of Proceedings to Vote in the Assembly

THAT the proceedings be suspended for no longer than 10 minutes, when a question is put in the Assembly, if a parliamentary group is not represented by a House Leader or Deputy House Leader, or by a Member designated to act on their behalf for the purposes of the vote, and has not notified the President that it will not take part in the vote;

THAT the Secretary General or a Table officer notify the House Leaders and Whips of the parliamentary groups, as well as their offices, and the independent Members and committee clerks of the suspension of proceedings for the purpose of putting a question to the Assembly;

THAT the committee on which a House Leader or a Deputy House Leader, or a Member designated to act on their behalf for voting purposes, is sitting suspend its proceedings, at the latter's request, to allow that person to make his or her way to the National Assembly Chamber;

20 October 2020

THAT the Secretary General or a Table officer notify the committee secretariat after the President has declared the result of the vote or, in the event of successive votes, after the President has declared the results of the last vote so that the committee may resume its proceedings not later than 5 minutes afterward;

Business Standing in the Name of Members in Opposition

THAT, during debates on business standing in the name of Members in Opposition, lack of quorum may not be raised, unless,

- in the case of a motion moved by the Official Opposition, less than 5 Members from the parliamentary group forming the Official Opposition are present in Chamber;
- in the case of a motion moved by the Second Opposition Group, less than 2 Members from the parliamentary group forming the Second Opposition Group are present in Chamber;
- in the case of a motion moved by the Third Opposition Group, less than 2 Members from the parliamentary group forming the Third Opposition Group are present in Chamber;
- in the case of a motion moved by an independent Member, less than 2 independent Members are present in Chamber;

Debates upon Adjournment

THAT the debates upon adjournment scheduled to be held on Thursday at 6:00 p.m. under Standing Order 309 be held on Thursday as of 1:00 p.m.;

THAT the suspension of proceedings be delayed accordingly;

Parliamentary Committees

General Provisions

THAT the Members participating in the proceedings of a parliamentary committee be entitled to take the floor and vote from any desk set up for that purpose by the Chair;

THAT, insofar as the room in which the committee must meet is equipped with the technology required for this purpose, all witnesses be heard by video conference, unless the committee decides otherwise at the request of a witness;

THAT a parliamentary committee be allowed to hold any given meeting simultaneously in the Louis-Joseph-Papineau Room and the Louis-Hippolyte-LaFontaine Room, using the technological means necessary;

THAT, despite the preceding paragraph, under an agreement between the parliamentary groups concerning one or more specific committee sittings, only the Louis-Joseph-Papineau Room be used to hear witnesses by video conference;

THAT all votes during proceedings of the Committee on the National Assembly and the Committee on Public Administration, except votes held during deliberative meetings, be conducted in keeping with the procedure set out for recorded divisions;

Voting Procedure for Certain Parliamentary Committee Proceedings

THAT, when a parliamentary committee meeting is held in the Legislative Council Chamber, the Marie-Claire Kirkland Room or the Pauline-Marois Room, one or more Members from the parliamentary group forming the Government, as the case may be, be authorized to exercise, by proxy, the number of voting rights determined under the applicable scenario among those described in the Appendix;

20 October 2020

THAT, when a parliamentary committee meeting is held in the Marie-Claire Kirkland Room or the Pauline-Marois Room, a Member from the parliamentary group forming the Official Opposition be authorized to exercise a voting right by proxy in the cases indicated in the scenarios in the Appendix and that the Member whose voting right is exercised by proxy be allowed to attend a parliamentary committee meeting in replacement of a colleague so that the Member may exercise his or her right to speak;

THAT, not later than at the beginning of such a meeting, the Government House Leader and the Official Opposition House Leader inform the committee clerk, who in turn informs the committee members at the beginning of the meeting, of the names of the Members who will be voting by proxy for the full duration of the meeting, and for each of them, the name of the Member who will be voting on their behalf;

THAT, during the vote of each parliamentary group, the clerk first call the Members present, then individually call the Members exercising their right to vote by proxy;

THAT the names of the Members who participated in the vote be recorded in the minutes of the meeting;

THAT, when an independent Member wishes to avail himself or herself of Standing Order 133, the number of Members from the parliamentary group forming the Government authorized to vote by proxy be increased by one;

THAT the independent Member who wishes to participate in the proceedings of a parliamentary committee of which he or she is not a member so notify that committee's clerk and the House Leaders of the parliamentary groups, not later than noon on the Monday preceding the date of the committee meeting or on the same day, if it is a Monday;

THAT, if the independent Member is informed later than noon Monday that a committee will be meeting that week, the deadline provided for in the preceding paragraph be extended to three hours after the time the Member is informed that a meeting is to be held;

Final Provision

THAT this motion take precedence over any incompatible provisions of the Standing Orders.
