Moment of reflection

The President informed the Assembly that he had, within the prescribed time, received a request for an urgent debate from the House Leader of the Second Opposition Group. This request concerns the tragic events that occurred recently in Québec's capital.

#### **RULING FROM THE CHAIR**

To be receivable, a request for an urgent debate must concern a specific, important matter that falls under the Assembly's jurisdiction. Furthermore, the object of the debate must concern a sudden, acute crisis or the worsening of such a crisis. The Chair must also take into consideration whether the matter has been discussed in other circumstances and whether there will be upcoming opportunities to do so.

According to those criteria, the purpose of an urgent debate is, in particular, to discuss a crisis that is sudden, acute or worsening, but still ongoing, and that, generally, concerns a large portion of the population.

The events that occurred last weekend are tragic, but as regards the request for an urgent debate, it cannot be concluded that they have caused a sudden and acute crisis, as defined by jurisprudence, to arise.

The House Leader of the Second Opposition Group raised the issue of the psychological and social impacts of those events. This topic is especially important in the current context of the pandemic and will continue to be the subject of much debate in the Assembly. The interpellation and the motions moved during Business Standing in the Name of Members in Opposition are ideal opportunities for debating issues like this within the framework of proceedings.

Accordingly, the request for an urgent debate is out of order.

THAT it solemnly recall that all individuals in Québec have fundamental rights and freedoms guaranteed by the Québec *Charter of human rights and freedoms* and by the *Canadian Charter of Rights and Freedoms*, such as the right to life, security, personal inviolability, dignity and equality;

THAT it recall that many Asian Quebecers, in particular those of Cambodian, Chinese, Korean, Japanese, Philippine and Vietnamese origin, make major contributions to Québec's prosperity and its economic, social and cultural development; THAT it recall that such racist acts in no way reflect Quebecers' values of openness and tolerance;

THAT it ask the Québec government to intensify its efforts to develop harmonious intercultural relations, in particular by championing respect and dignity for all;

THAT, lastly, it ask the Québec government to provide Ville de Montréal with all the resources deemed necessary to ensure greater vigilance to prevent such wrongdoings.

#### Information on the Proceedings of the Assembly

The President informed the Assembly that on Wednesday, 4 November 2020 during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Ms. Anglade, Leader of the Official Opposition.

This motion reads as follows:

THAT the National Assembly acknowledge that the pandemic and its many impacts have significantly increased the level of distress among Quebecers, whether they be seniors deprived of contact with their loved ones, young people deprived of places to socialize, families and entrepreneurs affected by an unexpected source of economic insecurity, health workers or women who bear an increased mental load as a result of all the upheaval; THAT it recognize that despite the recent announcements, mental health resources are struggling to meet all the needs within reasonable time frames, be they for access to adult and child psychiatrists or psychologists who can treat anxiety, distress and serious mental illness;

THAT it affirm the need to hold a societal debate on the issue of access to mental health care and to initiate this debate soon in the National Assembly, in collaboration with subject matter experts;

THAT the Assembly ask the four parliamentary group House leaders to meet in a timely manner to set up a non-partisan special parliamentary committee to hear from experts on mental health issues, in particular in the context of the pandemic, and to make recommendations to support the Government's short- and mid-term actions to carefully determine the scope of the problem, evaluate best practices from around the world, raise public awareness of the magnitude of the problem and engage civil society so that everyone does their part to help people around them who are vulnerable;

THAT the independent Members be able to take part in the committee's proceedings;

THAT the special parliamentary committee report to the National Assembly not later than 18 February 2021, unless the committee decides otherwise;

THAT, lastly, the Assembly call on the Government to continue its efforts by allocating all the necessary resources so that people who require psychotherapy to recover can receive it without financial hurdles and within similar time frames in both private practice and the public sector.
