(1) Resuming the debate, adjourned on **27 October 2021** in the name of the Member for Richelieu, on the motion by the Premier, —That this Assembly approves the general policy of the Government,

THAT the National Assembly severely censure the Premier for having presented an assessment of the Government's actions without including a true innovative and ambitious vision for Québec's future and solutions for the two major crises that Québec faces: the fight against climate change and the labour shortage.

The Member for Marguerite-Bourgeoys:

THAT the National Assembly severely censure the CAQ government for its lack of vision and lack of a plan for the future development of higher education in Québec.

The Member for Jonquière:

THAT the National Assembly severely censure the CAQ government for its lack of vision and ambition as regards environmental protection and the fight against climate change, as well as for the lack of a serious and credible plan to deal with the climate emergency.

The Member for Sainte-Marie–Saint-Jacques:

THAT the National Assembly severely censure the Coalition avenir Québec government for its inability to identify the causes that negatively affect the mental health and well-being of our young adults and to take action in this regard.

The Member for Verdun:

THAT the National Assembly severely censure the CAQ Government for its lack of coherence as regards the fight against climate change and the lack of a concrete plan to achieve the Québec targets for reducing GHG emissions.
