The Assembly proceeded to Oral Question Period.

#### **Motions Without Notice**

By leave of the Assembly to set aside Standing Order 185, Ms. Ménard (Laporte), together with Ms. Girault, Minister of International Relations and La Francophonie, Mr. Fontecilla (Laurier-Dorion), Mr. Arseneau, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure), Mr. LeBel (Rimouski) and Ms. Montpetit (Maurice-Richard), moved:

THAT the National Assembly strongly denounce the unjustified Russian invasion of Ukraine;

THAT it denounce Russia's violation of the territorial integrity of a sovereign State, which contravenes international law, and that it demand an immediate ceasefire;

THAT it recall that the present conflict is a frontal attack on Ukrainian democracy and on all democracies of the world;

THAT it denounce the Russian bombardment of civilian infrastructure, in particular hospitals and schools, which has resulted in the deaths of many innocent civilians;

THAT it reiterate the importance of freedom of the press and denounce threats to journalists' safety and the passing of laws that compromise this freedom;

THAT it be concerned about the humanitarian consequences of this conflict which, so far, has displaced over 3 million Ukrainians, mostly women and children, fleeing the horrors of the war;

THAT, lastly, it applaud the courage of the Ukrainian people and reaffirm its unwavering support for the citizens of that country and for all those belonging to the great Ukrainian diaspora in Québec during these uncertain times.

The question was put on this motion, and a recorded division was thereupon demanded.

By leave of the Assembly to set aside Standing Order 185, Ms. Lessard-Therrien (Rouyn-Noranda—Témiscamingue), together with Ms. Melançon (Verdun), Mr. Arseneau, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure), Mr. LeBel (Rimouski) and Ms. Montpetit (Maurice-Richard), moved:

THAT the National Assembly highlight the exceptional work carried out by midwives throughout the pandemic;

THAT it acknowledge that despite the perinatal policy "Politique de périnatalité 2008–2018", only 4.5% of pregnant women and people have access to their services;

THAT it recognize the known benefits of midwife followups in the current model on the health of mothers and newborns;

THAT it also recognize that the pandemic has created an increase in requests for follow-ups with midwives and that more and more women want to give birth outside a hospital;

THAT it deplore the fact that increasing wait times, the absence of obstetric services and the lack of real birthplace options limit the freedom of choice for women and families in a perinatal context;

THAT it acknowledge that the midwives' collective agreement expired on 31 March 2020 and that they are still waiting for an offer from the Government;

THAT the National Assembly urge the Government to begin, without delay, negotiations for the renewal of the midwives' collective agreement in order to improve their conditions of employment to promote the development of midwife services in Québec.

The question was put on this motion, and a recorded division was thereupon demanded.

By leave of the Assembly to set aside Standing Order 185, Mr. Bonnardel, Minister of Transport, together with Mr. Fortin, Official Opposition House Leader, Ms. Dorion (Taschereau), Mr. Arseneau, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure), Mr. LeBel (Rimouski) and Ms. Montpetit (Maurice-Richard), moved:

THAT the National Assembly mark National Impaired Driving Prevention Week, held from 20 to 26 March 2022;

THAT it deplore the fact that impaired driving is one of the main causes of accidents in Québec and that each year, an average of 85 people die and 220 more are seriously injured due to drinking and driving;

THAT it recall that impaired driving is a dangerous and criminal act that can have very serious consequences;

THAT it affirm the need for drivers to not drive while they are impaired.

#### **Government Bills**

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 24, An Act to amend the Act respecting the Québec correctional system to provide for the power to require that an offender be connected to a device that allows the offender's whereabouts to be known.

After debate thereon, the report was concurred in.

Passage in Principle

Mr. Julien, Minister of Energy and Natural Resources, moved that Bill 21, An Act mainly to end petroleum exploration and production and the public financing of those activities, do now pass in principle.

At 1:00 p.m., Mr. Picard, First Vice-President, suspended the proceedings until  $3:00\ \mathrm{p.m.}$ 

Accordingly, pursuant to Standing Order 97, the debate on the motion moved by Mr. Julien, Minister of Energy and Natural Resources, was adjourned in the name of Mr. Leitão (Robert-Baldwin).

#### **Business Standing in the Name of Members in Opposition**

Mr. Leduc (Hochelaga-Maisonneuve) moved:

THAT the National Assembly acknowledge the constantly rising inflation, which has a huge impact on the cost of living for citizens, especially for those with a modest income;

THAT it note that the Government's planned increase in the minimum wage does not enable workers to absorb the increasing costs;

THAT the National Assembly ask the Government to introduce a plan to gradually increase the minimum wage to at least \$18 per hour by 1 May 2023 to ensure the predictability of such increases;

THAT the National Assembly ask the Government to include support measures for small businesses and the community in its plan to increase the minimum wage.

Ms. Gaudreault, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; 46 minutes 15 seconds to the parliamentary group forming the Government; 27 minutes 29 seconds to the parliamentary group forming the Official Opposition; 21 minutes 39 seconds to the Second Opposition Group; 7 minutes 7 seconds to the Third Opposition Group; and 7 minutes 30 seconds to the independent Members, subject to a maximum of 2 minutes each. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At the beginning of his address, Mr. Tanguay (LaFontaine) moved:

THAT the motion moved by the Member for Hochelaga-Maisonneuve be amended as follows:

By replacing, in the 7th line, after the words "the Government", the words "to introduce a plan to gradually increase the minimum wage to at least \$18 per hour by 1 May 2023 to ensure the predictability of such increases;" by the words "to hold broad special consultations to establish the next minimum wage increase planned for 1 May 2023;".

The motion, as amended, would read as follows:

THAT the National Assembly acknowledge the constantly rising inflation, which has a huge impact on the cost of living for citizens, especially for those with a modest income;

THAT it note that the Government's planned increase in the minimum wage does not enable workers to absorb the increasing costs;

THAT the National Assembly ask the Government to hold broad special consultations to establish the next minimum wage increase planned for 1 May 2023;

THAT the National Assembly ask the Government to include support measures for small businesses and the community in its plan to increase the minimum wage.

The debate continued on the main motion moved by Mr. Leduc (Hochelaga-Maisonneuve) and on the amendment motion moved by Mr. Tanguay (LaFontaine), subject to the permission of its author.

Pursuant to Standing Order 98.1, Mr. Leduc (Hochelaga-Maisonneuve) refused the amendment proposed by Mr. Tanguay (LaFontaine).

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Schneeberger, Deputy Government House Leader, the division on the motion moved by Mr. Leduc (Hochelaga-Maisonneuve) was deferred until Routine Proceedings on the next sitting day.

#### **Government Bills**

#### Passage in Principle

The Assembly resumed the debate, which had been adjourned earlier in the sitting, on the motion moved by Mr. Julien, Minister of Energy and Natural Resources, that Bill 21, An Act mainly to end petroleum exploration and production and the public financing of those activities, do now pass in principle.

The debate being concluded, the motion was carried and Bill 21 was accordingly passed in principle.

Mr. Charette, Minister of the Environment and the Fight Against Climate Change, moved that Bill 21 be referred to the Committee on Agriculture, Fisheries, Energy and Natural Resources for clause-by-clause consideration.

The motion was carried.

#### **Private Members' Public Bills**

Passage in Principle

Mr. Birnbaum (D'Arcy-McGee) moved that Bill 498, An Act to proclaim the National Day for the Promotion of Positive Mental Health, do now pass in principle.

The debate was adjourned in the name of Mr. Birnbaum (D'Arcy-McGee).
