Motion moved by the Minister of Finance, –That this Assembly approve the budgetary policy of the Government,

And motions stating a grievance moved by:

The Member for Robert-Baldwin:

THAT the National Assembly severely censure the CAQ government for tabling an electoral budget that does not propose any long-term solutions to address the rising cost of living that affects all citizens of Québec.

The Member for Mercier:

THAT the National Assembly severely censure the CAQ government for its 2022–2023 budget, which has prioritized the Government’s election needs at the expense of Quebecers’ needs in dealing with the crises they must face: the cost of living crisis, the housing crisis, the public services crisis and the climate crisis.

The Leader of the Official Opposition:

THAT the National Assembly severely censure the CAQ government for its lack of vision in the fight against climate change and in economic development, in particular for the development of the green hydrogen industry.

The Member for Rosemont:

THAT the National Assembly censure the Government for its budgetary choices that favour the private sector and undermine our public health system.

The Member for Mont-Royal □ Outremont:

THAT the National Assembly severely censure the CAQ government for developing a QIP beyond the Government's delivery capacity, without trying to significantly increase that capacity, while many calls for tenders have been cancelled or taken back and the Government has lagged behind considerably in paying construction companies.

The Opposition House Leader:

THAT the National Assembly severely censure the CAQ government for its lack of leadership with respect to Outaouais projects, as the QIP budget for projects in health, education, higher education, the road network, public transit and all areas is disproportionately low for Outaouais's population.

The Member for Rouyn-Noranda-Témiscamingue:

THAT the National Assembly censure the CAQ government for its 2022–2023 budget, which does not provide the resources or means necessary to meet the requirements of protecting the environment and fighting against climate change.

The Member for D'Arcy-McGee:

THAT the National Assembly severely censure the CAQ government for its refusal to increase budgets for mental health and to reduce the unprecedented wait times to consult a psychologist, in order to respond in particular to the steep rise in the level of anxiety being experienced by Quebecers.

The Member for Gaspé:

THAT the National Assembly severely censure the CAQ government for its inaction on the housing crisis portfolio, for abandoning the AccèsLogis program and for the absence of structuring measures allowing both to contain the expansion of the real estate bubble and access to property for all Quebecers.

The Member for Jean-Lesage:

THAT the National Assembly censure the CAQ government for its lack of ambition with respect to the federal government and its resignation on the question of national identity.

The Member for Taschereau:

THAT the National Assembly censure the CAQ government for the unacceptable imbalance between investments in public transit and those in the road network in the 2022-2023 budget.

The Member for Duplessis:

THAT the National Assembly severely censure the CAQ government for its latest budget, which does not provide the necessary funds to begin a real shift toward home care.

The Member for Verdun:

THAT the National Assembly severely censure the CAQ government for its refusal to recognize the urgency of taking action to fight climate change by investing the bare minimum required by law, as well as for its reduction of incentives for the Roulez vert program.

The Member for Sainte-Marie–Saint-Jacques:

THAT the National Assembly censure the CAQ government for its budget, which does not contain the necessary investments to achieve the 40% reduction target for petroleum product consumption, set out in the 2030 Energy Policy.

The Member for Saint-Laurent:

THAT the National Assembly severely censure the CAQ government for not having made a concrete plan to remedy the urgent problem of the over 30,000 teachers who are not legally qualified and for having failed to substantially increase the number of places available for the qualifying master's degree.

The Leader of the Third Opposition Group:

THAT the National Assembly severely censure the CAQ government for not committing to abolishing the use of private placement agencies to reintegrate workers into the public health and social services network.

The Member for Westmount-Saint-Louis:

THAT the National Assembly severely censure the CAQ Government for its budget, which does not take into account Quebecers' food insecurity in the context of spiraling inflation.

The Member for Laurier-Dorion:

THAT the National Assembly severely censure the CAQ Government for its 2022–2023 budget, which does not include multi-year planning for the AccèsLogis program that addresses the needs of people who are inadequately housed.

The Member for Nelligan:

THAT the National Assembly severely censure the CAQ government which, once again, is abandoning Québec patients by not introducing any concrete measures to remedy the situation in the health network and end the increasingly long waiting lists.

The Member for Fabre:

THAT the National Assembly severely censure the CAQ government for its budget, which does not take into account seniors living at home and the most vulnerable in situations of financial precarity.

The Leader of the Second Opposition Group:

THAT the National Assembly severely censure the CAQ government for its failure to support Quebecers in dealing with the cost of living crisis.

The Member for Jonquière:

THAT the National Assembly severely censure the CAQ government for its lack of vision and ambition as regards environmental protection and the fight against climate change, as well as for the lack of a serious and credible plan to deal with the climate emergency.

The House Leader of the Second Opposition Group:

THAT the National Assembly censure the CAQ government for not providing enough funding for the missions of community organizations to ensure their sustainability.

Motion moved by the Member for Nelligan under Standing Order 97:

THAT the National Assembly deplore the fact that after nearly 4 years of a CAQ government, the number of Quebecers waiting for a family doctor has increased from 400,000 to more than one million;

THAT it recall that the Coalition Avenir Québec promised, during the 2018 election campaign, that a CAQ government would provide a family doctor for all Quebecers;

THAT it acknowledge that the CAQ government has broken its promise to Quebecers and no longer intends to provide a family doctor for all Quebecers;

THAT it recognize that the health reform tabled by the CAQ government will not solve the problems of access to primary care;

THAT it note that Quebecers are now paying the price for the CAQ government's inaction and lack of leadership in health care;

THAT, lastly, the National Assembly condemn the CAQ government's abandonment of access to a family doctor for all Quebecers.

To the Government

Since the start of the pandemic, the government has in some measure recognized the magnitude of the task facing health care workers. The government has accelerated the recruitment of attendants to try to alleviate the scarcity of these workers and has granted workers in this field what is now referred to as the “COVID-19 bonus” and has just extended it until May.

While financial compensation alone cannot provide relief to overworked employees, it at least sends a signal that the government recognizes the efforts being made by health care workers.

However, these are not the only workers in our public services system who have experienced significant additional pressure. Teachers have also had to achieve real feats of strength in the last 24 months.

During the pandemic, our teachers have had to adapt to a multitude of unprecedented situations. These include: suspending classes in the home stretch of the school year and then resuming again with all the challenges of bringing students up to speed after such interruptions, distance learning, hybrid education, which also involves bringing up to speed young students returning to school after a stay at home, compulsory mask wearing, canceling and reinstating mandatory mask wearing, having to constantly adapt to fluctuating COVID-19 cases, etc. The teaching profession was already very demanding, but became even more so during this pandemic, affecting the psychological wellbeing of our teachers.

Yet, despite this situation, and despite the fact that they hold the future of Québec in their hands, our teachers have not yet received any recognition from their employer – the government. They deserve some form of financial compensation.

My questions are the following:

Does the Government recognize the significant increase in the workload of Québec teachers due to the unprecedented context of the COVID-19 pandemic?

As a result of this situation and in order to be consistent with the compensation granted to health care workers, will the Government agree to grant a “COVID-19 bonus” to Québec’s teachers?
