The Assembly was called to order at 10:00 a.m.

Government Bills

Passage

Mr. Julien, Minister of Energy and Natural Resources, moved that Bill 21, An Act mainly to end petroleum exploration and production and the public financing of those activities, do now pass.

After debate thereon, the question was put on this motion, and a recorded division was thereupon demanded.

At the request of Mr. Schneeberger, Deputy Government House Leader, the division was deferred until Routine Proceedings of today's sitting.

Government Motions

The Assembly held the debate on the motion that arose from the tabling of the International Labour Organization's Violence and Harassment Convention, 2019 (No. 190), on 31 March 2022, by the Minister of International Relations and La Francophonie.

This motion reads as follows:

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly approve the International Labour Organization's Violence and Harassment Convention, 2019 (No. 190).

Mr. Picard, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 56 minutes 15 seconds to the parliamentary group forming the Government; 34 minutes 31 seconds to the parliamentary group forming the Official Opposition; 12 minutes 47 seconds to the Second Opposition Group; 8 minutes 57 seconds to the Third Opposition Group; and 7 minutes 30 seconds to the independent Members, subject to a maximum of 2 minutes each. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At 11:28 a.m., Mr. Picard, First Vice-President, suspended the proceedings for a few minutes.

The proceedings resumed at 11:39 a.m.

Pursuant to Standing Order 100, at the end of his address, Mr. Schneeberger, Deputy Government House Leader, moved the adjournment of the debate.

The motion was carried.

Accordingly, the debate on the motion that arose from the tabling of the International Labour Organization's Violence and Harassment Convention, 2019 (No. 190) on 31 March 2022 by the Minister of International Relations and La Francophonie, was adjourned.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Dubé, Minister of Health and Social Services, together with Mr. Derraji (Nelligan), Mr. Marissal (Rosemont), Mr. Arseneau, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure), Mr. LeBel (Rimouski) and Ms. Montpetit (Maurice-Richard), moved:

Whereas, in 2021, an estimated 57,500 Quebecers were diagnosed with cancer, and as this diagnosis is a huge shock that affects all aspects of their lives;

Whereas four out of ten cancers can be prevented by adopting a healthy lifestyle and by implementing health policies that protect Quebecers;

Whereas the funds raised by the Canadian Cancer Society's Daffodil Campaign will be used to finance research that will transform the future of treating the disease and an assistance and support network that will improve the lives of people with cancer and their loved ones:

Whereas cancer is the leading cause of death in Québec, yet the survival rate for all types of cancer combined has increased by 8%, rising from 55% in 1992 to 63% in 2019, thanks to funding for innovative research;

Whereas thousands of Canadian Cancer Society volunteers and donors in Québec share the common goal of honouring and supporting cancer patients and their loved ones;

Whereas the daffodil is a symbol of strength, courage and hope for cancer patients and their loved ones;

THAT the National Assembly of Québec encourage all Quebecers to take concrete actions during the Canadian Cancer Society's Daffodil Campaign to help people affected by cancer;

THAT, lastly, the National Assembly mark the month of April as Daffodil Month for Cancer Awareness.

By leave of the Assembly, the motion was carried.

This motion reads as follows:

THAT the National Assembly deplore the tragedy that occurred at the CHSLD Herron in which 47 seniors died during the first wave of the COVID-19 pandemic in the spring of 2020;

THAT it recall the alarming revelations about that tragedy that have resurfaced in the media in recent days;

THAT it reiterate the principle of ministerial responsibility in the management of events, according to which ministers are individually responsible for managing their departments and are accountable not only for their own actions, but also for the actions of the public servants in their department;

THAT, lastly, the National Assembly demand that the Government launch an independent public inquiry to shine a light on the circumstances surrounding those deaths, both for the victims' families and for the dignity of the deceased.
