#### **Oral Answers to Petitions**

The Assembly proceeded to Oral Question Period.

#### **Motions Without Notice**

Mr. Fortin, Opposition House Leader, together with Mr. Zanetti (Jean-Lesage), Mr. Arseneau, Leader of the Third Opposition Group, Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure), Ms. Samson (Iberville) and Mr. LeBel (Rimouski), moved a motion calling for the disclosure of the details of all road infrastructure projects in Québec; this motion could not be debated for want of unanimous consent.

Mr. Fontecilla (Laurier-Dorion), together with Ms. Nichols (Vaudreuil), Ms. Perry Mélançon (Gaspé) and Mr. Ouellette (Chomedey), moved a motion to bring forward Bill 892, An Act to broaden a lessee's right to have the rent fixed and to have other conditions of the lease modified by the Administrative Housing Tribunal, or for the tabling of another bill in this regard before 15 May 2022; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Gaudreault (Jonquière), together with Ms. Lessard-Therrien (Rouyn-Noranda–Témiscamingue), Mr. Ouellette (Chomedey), Mr. Roy (Bonaventure) and Mr. LeBel (Rimouski), moved:

THAT the National Assembly highlight the unanimous passage in principle of Bill 391, which asserts the primacy of Québec's jurisdiction in matters of the environment;

THAT it emphasize the fact that Québec's environmental sovereignty comes with increased responsibility on the part of the Québec government as well as a duty to set an example in environmental protection and the fight against climate change;

THAT it oppose any intervention by the federal government in matters of the environment on Québec territory;

THAT it deplore the federal government's intention to disregard Québec's legislative and regulatory framework aimed at protecting wildlife species in precarious situations;

THAT it recognize that the issuing of an emergency decree would undermine the full exercise of Québec's jurisdiction in matters of biodiversity protection as well as that relating to land-use planning.

The question was put on this motion; a recorded division was thereupon demanded.

THAT the National Assembly recognize the bicentennial celebrations of the Chamber of Commerce of Metropolitan Montreal in 2022, a truly historic milestone;

THAT it emphasize that this anniversary marks 200 years of involvement and achievements for the Montréal business community;

THAT it recognize the CCMM's commitment to contributing to prosperity for businesses and business leaders and, by extension, for Québec as a whole;

THAT it highlight the CCMM's role, as North America's largest francophone chamber of commerce, in developing a dynamic francophone business community;

THAT it recognize the CCMM's contribution to downtown Montréal's economic recovery and its goal of stimulating Montréal's business ecosystem.

By leave of the Assembly, the motion was carried.

#### ORDERS OF THE DAY

#### **Government Bills**

Passage in Principle

Mr. Dubé, Minister of Health and Social Services, moved that Bill 28, An Act to terminate the public health emergency, do now pass in principle.

A debate arose thereon.

At 1:00 p.m., Mr. Picard, First Vice-President, suspended the proceedings until  $3:00\ \text{p.m.}$ 

Accordingly, pursuant to Standing Order 97, the debate on the motion moved by Mr. Dubé, Minister of Health and Social Services, was adjourned in the name of Mr. Arseneau, Leader of the Third Opposition Group.

#### **Business Standing in the Name of Members in Opposition**

Mr. Arseneau, Leader of the Third Opposition Group, moved:

THAT the National Assembly deplore the tragedy that occurred at the CHSLD Herron in which 47 seniors died during the first wave of the COVID-19 pandemic in the spring of 2020;

THAT it recall the alarming revelations about that tragedy that have resurfaced in the media in recent days;

THAT it reiterate the principle of ministerial responsibility in the management of events, according to which ministers are individually responsible for managing their departments and are accountable not only for their own actions, but also for the actions of the public servants in their department;

THAT, lastly, the National Assembly demand that the Government launch an independent public inquiry to shine a light on the circumstances surrounding those deaths, both for the victims' families and for the dignity of the deceased.

Ms. Gaudreault, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; 46 minutes 15 seconds to the parliamentary group forming the Government; 27 minutes 48 seconds to the parliamentary group forming the Official Opposition; 10 minutes 18 seconds to the Second Opposition Group; 18 minutes 9 seconds to the Third Opposition Group; and 7 minutes 30 seconds to the independent Members, subject to a maximum of 2 minutes each. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Schneeberger, Deputy Government House Leader, the division on the motion moved by Mr. Arseneau, Leader of the Third Opposition Group, was deferred until Routine Proceedings on the next sitting day.

#### **Government Bills**

Report Stage

The Assembly took into consideration the report from the Committee on Health and Social Services on its clause-by-clause consideration of Bill 15, An Act to amend the Youth Protection Act and other legislative provisions, together with the amendments transmitted by Ms. Weil (Notre-Dame-de-Grâce) and Mr. Zanetti (Jean-Lesage).

The amendments were declared in order.

After debate thereon, the amendment proposed by Ms. Weil (Notre-Dame-de-Grâce) was negatived.

The amendments proposed by Mr. Zanetti (Jean-Lesage) were negatived.

The report was concurred in.

Passage in Principle

The Assembly resumed the debate, which had been adjourned earlier in the sitting, on the motion moved by Mr. Dubé, Minister of Health and Social Services, that Bill 28, An Act to terminate the public health emergency, do now pass in principle.

The debate was adjourned in the name of Mr. Leitão (Robert-Baldwin).

At 6:30 p.m., Ms. Soucy, Second Vice-President, adjourned the Assembly until Thursday, 14 April 2022 at 9:40 a.m.
