**An Act respecting academic freedom in

Section 3

AMENDMENT:

1. In the first paragraph:
 - (a) Add “, such as institutional censorship,” after “constraint”.
 - (b) Strike out “, in their field of activity,”.
2. Replace the second paragraph by:

That right includes the person’s freedom

 - (1) to teach and discuss;
 - (2) to research, create and publish;
 - (3) to express their opinion about society and about an institution, including their respective institution, and about any doctrine, dogma or opinion; and
 - (4) to freely take part in the activities of professional organizations or academic organizations.
