Business Having Precedence

Opening Speech Debate

The Assembly resumed the debate, which had been adjourned on 7 December 2022, on the Opening Speech of the Session, on the motion moved by Mr. Legault, Premier, and on the motions stating a grievance moved by Mr. Tanguay, Leader of the Official Opposition, Mr. Marissal (Rosemont), Ms. Maccarone (Westmount–Saint-Louis), Mr. Beauchemin (Marguerite-Bourgeoys), Ms. Dufour (Mille-Îles), Mr. Zanetti (Jean-Lesage), Mr. Grandmont (Taschereau), Ms. Zaga Mendez (Verdun), Ms. Caron (La Pinière), Mr. Fontecilla (Laurier-Dorion), Mr. Morin (Acadie), Ms. Cadet (Bourassa-Sauvé), Ms. Labrie (Sherbrooke), Ms. McGraw (Notre-Dame-de-Grâce) and Ms. Massé (Sainte-Marie–Saint-Jacques), subject to the receivability of these motions.

At the end of his address, Mr. Fortin (Pontiac) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Government for its lack of a concrete plan to make up for delayed surgeries.

At 1:00 p.m., Mr. Lévesque, Second Vice-President, suspended the proceedings until 3:00 p.m.

The proceedings resumed at 3:00 p.m.

By leave of the Assembly to set aside Standing Order 53, the Assembly proceeded to hear a motion without notice.

Motions Without Notice

Mr. Caire, Deputy Government House Leader, moved:

THAT, for the purposes of considering Bill 1, An Act to limit the indexation of several government tariffs, and Bill 4, An Act to recognize the oath provided in the Act respecting the National Assembly as the sole oath required in order to sit in the Assembly, the Assembly permit the carrying out of all the legislative stages for these bills during the same sitting day;

THAT, today, immediately following Business Having Precedence, the debate on the passage in principle of Bill 1, An Act to limit the indexation of several government tariffs, be held;

THAT, not later than 10:30 p.m., the question be put on the passage in principle of the bill, and the vote thereon be by a show of hands;

THAT the bill be referred to the Committee of the Whole for clause-by-clause consideration;

THAT, as soon as Orders of the Day for the Friday, 9 December 2022 sitting are called, the Assembly resolve itself into a Committee of the Whole in order to undertake clause-byclause consideration of Bill 1, An Act to limit the indexation of several government tariffs;

THAT, at the opening of proceedings in Committee of the Whole, the Minister read all the sections;

THAT the clause-by-clause consideration of the bill in Committee of the Whole that follows be limited to 1 hour 15 minutes, including three 15-minute periods for the Official Opposition and two 15-minute periods for the Second Opposition Group, alternately;

THAT the individual addresses may relate to all sections of the bill;

THAT, at the conclusion of the debate, the question be put on the amendments, sections and all remaining elements of the bill, and the vote thereon be by a show of hands;

THAT, immediately thereafter, the Committee of the Whole report to the Assembly;

THAT, immediately thereafter, the question be put on the report from the Committee of the Whole, and the vote thereon be by a show of hands;

THAT, immediately thereafter, the question be put on the passage of Bill 1, An Act to limit the indexation of several government tariffs, and the vote thereon be by a show of hands;

THAT, immediately thereafter, the question be put on the passage in principle of Bill 4, An Act to recognize the oath provided in the Act respecting the National Assembly as the sole oath required in order to sit in the Assembly, and the vote thereon be by a show of hands;

THAT, immediately thereafter, this bill be referred to the Committee of the Whole for drafting;

THAT, immediately thereafter, the Assembly resolve itself into a Committee of the Whole for drafting;

THAT, immediately thereafter, the Committee of the Whole report to the Assembly;

THAT, immediately thereafter, the question be put on the report from the Committee of the Whole, and the vote thereon be by a show of hands; THAT, immediately thereafter, the Assembly undertake the debate on the passage of the bill;

THAT, during this debate, an individual from each parliamentary group speak for no longer than 5 minutes;

THAT, immediately thereafter, the question be put on the passage of Bill 4, An Act to recognize the oath provided in the Act respecting the National Assembly as the sole oath required in order to sit in the Assembly, and the vote thereon be by a show of hands;

THAT, at any time during the proceedings, a Minister or Deputy Government House Leader be permitted to move the suspension of the proceedings, the adjournment of the debate and the adjournment of the Assembly; that such a motion require no notice, cannot be amended or debated and that the question be immediately put thereon;

THAT this motion take precedence over any incompatible provision of the Standing Orders;

THAT, despite Standing Order 20, the Committee of the Whole and the Assembly be permitted to continue their proceedings of Friday, 9 December 2022 until the latter has completed the business described in this motion;

THAT this motion become an order of the Assembly.

By leave of the Assembly, the motion was carried.

Opening Speech Debate

The debate being concluded, Mr. Benjamin, Third Vice-President, declared that the motions stating a grievance were receivable, except the motion moved by Ms. Labrie (Sherbrooke), with respect to which he ruled the following:

RULING FROM THE CHAIR

The motion stating a grievance moved by Ms. Labrie (Sherbrooke) within the framework of the Opening Speech is not receivable on the grounds that, contrary to Standing Order 191, it contains arguments.

In the past, parliamentary jurisprudence has explained that argumentation is understood to mean anything which tends to support the conclusion sought in the motion. The Chair has already declared out of order motions whose wording was similar to that of the motion moved by the Member for Sherbrooke.

On behalf of the Member concerned, Mr. Benjamin, Third Vice-President, requested that the Assembly grant leave to replace the aforementioned unreceivable motion by a new motion that complies with the Standing Orders; this motion could not be tabled for want of unanimous consent.

Mr. Benjamin, Third Vice-President, then proceeded to put the question on the motions stating a grievance moved during the debate.

First, the question was put on the motion stating a grievance moved by Mr. Tanguay, Leader of the Official Opposition. This motion reads as follows:

THAT the National Assembly denounce the CAQ government's lack of vision to resolve the most pressing issues that Quebecers are facing, in particular the labour shortage, the fight against inflation and access to quality health care.

A recorded division was thereupon demanded.

At the request of Mr. Caire, Deputy Government House Leader, the recorded divisions were deferred until Routine Proceedings on the next sitting day.

Government Bills

Passage in Principle

Pursuant to the order adopted earlier, Mr. Girard, Minister of Finance, moved that Bill 1, An Act to limit the indexation of several government tariffs, do now pass in principle.

After debate thereon, the question was put on this motion; pursuant to the order adopted earlier, a vote by a show of hands was taken.

The motion was carried and, accordingly, Bill 1 was passed in principle.

Pursuant to the order adopted earlier, Bill 1 was referred to the Committee of the Whole for clause-by-clause consideration.

Mr. Caire, Deputy Government House Leader, moved the adjournment of the Assembly until Friday, 9 December 2022 at 9:40 a.m.

The motion was carried.

Accordingly, at 8:21 p.m., Mr. Benjamin, Third Vice-President, adjourned the Assembly until Friday, 9 December 2022 at 9:40 a.m.
