The Assembly was called to order at 10:00 a.m. Moment of reflection ORDERS OF THE DAY **Government Bills** Passage in Principle Mr. Fitzgibbon, Minister of Economy, Innovation and Energy, moved that Bill 2, An Act mainly to cap the indexation rate for Hydro-Québec domestic distribution rate prices and to further regulate the obligation to distribute electricity, do now pass in principle. After debate thereon, the motion was carried and, accordingly, Bill 2 was passed in principle. Mr. Lévesque, Deputy Government House Leader, moved that Bill 2 be referred to the Committee on Agriculture, Fisheries, Energy and Natural Resources for clause-byclause consideration. The motion was carried. At 11:06 a.m., at the request of Mr. Lévesque, Deputy Government House Leader, Mr. Lévesque, Second Vice-President, suspended the proceedings until 1:40 p.m.

The Assembly proceeded to Oral Question Period.

#### **Motions Without Notice**

Mr. St-Pierre Plamondon, Leader of the Third Opposition Group, together with Ms. McGraw (Notre-Dame-de-Grâce), Ms. Zaga Mendez (Verdun) and Ms. Nichols (Vaudreuil), moved a motion on the construction of a hydroelectric dam on the Magpie River; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Drainville, Minister of Education, together with Ms. Rizqy (Saint-Laurent), Ms. Ghazal (Mercier), Mr. Bérubé (Matane-Matapédia) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly mark Teacher Appreciation Week, held from 5 to 11 February under the theme "Everyday we measure the significance of your role";

THAT it highlight the dedication of teachers and their invaluable contribution to shaping the society of today and tomorrow;

THAT it recognize the importance of concretely supporting teachers, in particular with innovative projects such as the teacher's aide pilot project, which lets them concentrate on their teaching tasks and meets the daily needs of students;

THAT it recognize the key role of teachers in students' educational success and well-being;

THAT, lastly, it invite all Quebecers to thank the teaching staff who take care of and guide our youth and adult learners throughout the school year.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Derraji, Official Opposition House Leader, together with Ms. Blanchette Vézina, Minister of Natural Resources and Forests, and Mr. Bérubé (Matane-Matapédia), moved:

THAT the National Assembly acknowledge the Federal Electoral Boundaries Commission's proposal to eliminate the federal riding of Avignon–La Mitis–Matane–Matapédia;

THAT it underline this region's vastness, remoteness, long travel distances and scattered population;

THAT it recall that such a vast territory would further widen the distance between citizens and their Member, would affect the quality of services offered by riding offices and would not adequately reflect the riding's regional differences;

THAT it highlight that any loss of political weight by our Québec regions jeopardizes our nation's democratic health;

THAT, lastly, it express its wish that the Federal Electoral Boundaries Commission reconsider its recommendation to eliminate this riding.

By leave of the Assembly, the motion was carried.

Mr. Fontecilla (Laurier-Dorion), together with Mr. Derraji (Nelligan), Mr. Bérubé (Matane-Matapédia) and Ms. Nichols (Vaudreuil), moved a motion on a plan to combat Islamophobia; this motion could not be debated for want of unanimous consent.

#### **Notices of Proceedings in Committees**

Mr. Lévesque, Deputy Government House Leader, convened the following committee:

the Committee on Public Finance, to continue its public hearings within the framework of special consultations on Bill 3, An Act respecting health and social services information and amending various legislative provisions.

Ms. Soucy, First Vice-President, gave the following notices:

- the Committee on Culture and Education shall hold a deliberative meeting to organize its proceedings and discuss the possibility of examining a petition on implementing the veterinary medicine program in La Pocatière;
- the Committee on Health and Social Services shall hold a deliberative meeting to organize its proceedings and discuss the possibility of examining a petition on a request to make dementia prevention a health priority.

#### **Information on the Proceedings of the Assembly**

Ms. Soucy, First Vice-President, informed the Assembly that on Wednesday, 8 February 2023, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Ms. Dufour (Mille-Îles).

This motion reads as follows:

THAT the National Assembly note that the housing situation and access to property have deteriorated over the past five years;

THAT it acknowledge that Quebecers who are lessees face multiple factors that apply significant pressure on rent costs, including:

- the housing shortage, as demonstrated by the general decline in the rental property vacancy rate in Québec in 2022;
- the rising cost of living;

- the decreasing affordability of housing throughout Ouébec;
- the shortage of housing adapted to the needs of families:

THAT it also note the shortage of social housing throughout Québec intended for lower-income earners as well as the increasing obsolescence of a number of these buildings;

THAT it acknowledge that a generation of Quebecers' access to property is currently compromised by the rising cost of property, the reduction in the number of housing starts, the increase in construction costs, the labour shortage in the construction sector and the increase in interest rates;

THAT it note that the measures implemented by the CAQ government to curb the housing crisis in Québec have so far been insufficient;

THAT it recognize that the many processes of the different government levels, including housing organizations, are too lengthy and complex, and that streamlining programs is necessary;

THAT, lastly, it demand that the Québec government take on this mission of the State by establishing a true national housing strategy to simultaneously address the availability of social housing, the affordability of rental housing and access to property.

THAT a period of 12 minutes be set aside for opening statements, allocated as follows: 6 minutes to the parliamentary group forming the Government, 3 minutes 36 seconds to the Official Opposition, 1 minute 12 seconds to the Second Opposition Group and 1 minute 12 seconds to the independent Member;

THAT the presentation by each organization last no longer than 10 minutes and the exchange with the Committee members last no longer than 35 minutes, allocated as follows: 17 minutes 30 seconds to the parliamentary group forming the Government, 10 minutes 30 seconds to the Official Opposition, 3 minutes 30 seconds to the Second Opposition Group and 3 minutes 30 seconds to the independent Member;

THAT a 5-minute interval be scheduled between discussions with each individual or organization;

THAT the Minister of Justice be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

At 3:31 p.m., at the request of Mr. Lévesque, Deputy Government House Leader, Ms. Soucy, First Vice-President, suspended the proceedings until 6:30 p.m.

#### **Debates upon Adjournment**

At 6:30 p.m., the Assembly held a debate upon adjournment on a question from Mr. Beauchemin (Marguerite-Bourgeoys) to Mr. Girard, Minister of Finance, about the worsening financial situation of Québec households.
