The Assembly was called to order at 9:40 a.m.

ROUTINE PROCEEDINGS

Statements by Members

Ms. Poulet (Laporte) made a statement to pay tribute to Ms. Sylvie Dubois, recipient of the Insigne du mérite award from the Ordre des infirmières et infirmiers du Québec.

Ms. Blais (Abitibi-Ouest) made a statement to underline the success of the Centre de formation professionnelle Lac-Abitibi's Apprentis spécialisés program.

Mr. Leduc (Hochelaga-Maisonneuve) made a statement to underline the 50th anniversary of the Centre communautaire culturel, social et éducatif Maisonneuve.

By leave of the Assembly to set aside Standing Order 54.1, Mr. Lévesque (Chauveau) made a statement to underline the 30th anniversary of Télébingo Rotary.

Ms. Lakhoyan Olivier (Chomedey) made a statement to express solidarity with and support for the family and friends of the victims of the earthquake that struck Turkey and Syria on 6 February 2023.

Mr. Schneeberger (Drummond–Bois-Francs) made a statement to underline the work of the organization La Piaule Centre-du-Québec.

Mr. Tremblay (Dubuc) made a statement to applaud the work of the "éclaireurs" network of Saguenay–Lac-Saint-Jean.

Ms. Grondin (Argenteuil) made a statement to congratulate Ms. Denise Cloutier, recipient of the Prix Femmes d'affaires du Québec award.

Ms. Soucy (Saint-Hyacinthe) made a statement to pay tribute to Ms. Linda Normandeau, founder of the "Municipalités engagées contre la violence conjugale" movement.

Mr. Lafrenière (Vachon) made a statement to pay tribute to Mr. Fady Dagher, Director of the Service de police de l'agglomération de Longueuil.

Ms. Garceau (Robert-Baldwin) made a statement to underline the International Day of Women and Girls in Science.

At 9:54 a.m., Mr. Benjamin, Third Vice-President, suspended the proceedings for a few minutes.

The proceedings resumed at 10:02 a.m.

At the request of the President, the Assembly observed a moment of silence in memory of the victims of the tragic event that occurred in Laval on 8 February 2023.

Introduction of Bills

Ms. LeBel, Minister Responsible for Government Administration and Chair of the Conseil du trésor, moved that leave be granted to introduce the following bill:

9 An Act amending mainly certain Acts establishing public sector pension plans

The motion was carried.

Accordingly, Bill 9 was introduced in the Assembly.

Mr. Girard, Minister of Finance, tabled the following:

Presenting Reports from Committees

Mr. Ciccone (Marquette), Committee Chair, tabled the following:

The report from the Committee on Agriculture, Fisheries, Energy and Natural Resources, which met on 8 February 2023 for clause-by-clause consideration of Bill 2, An Act mainly to cap the indexation rate for Hydro-Québec domestic distribution rate prices and to further regulate the obligation to distribute electricity. The report contains amendments to the bill.

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Bérubé (Matane-Matapédia) tabled the following:

A study published in *BMJ Open* by R. Fleet, F. Lauzier, F. K. Tounkara et al., entitled "Profile of trauma mortality and trauma care resources at rural emergency departments and urban trauma centres in Québec: a population-based, retrospective cohort study".

Deferred Divisions

The Assembly took the division, which had been deferred on 8 February 2023, on the motion moved by Ms. Dufour (Mille-Îles) and on the amendment motion moved by Ms. Duranceau, Minister Responsible for Housing, under Business Standing in the Name of Members in Opposition.

The question was first put on the amendment motion moved by Ms. Duranceau, Minister Responsible for Housing.

This motion reads as follows:

THAT the motion moved by the Member for Mille-Îles be amended as follows:

- 1. By striking out the fifth paragraph;
- 2. By replacing the words "a true national housing strategy" in the seventh paragraph by the words "a housing action plan".

The motion was carried on the following vote:

The question was then put on the motion moved by Ms. Dufour (Mille-Îles), as amended.

This motion reads as follows:

THAT the National Assembly note that the housing situation and access to property have deteriorated over the past five years;

THAT it acknowledge that Quebecers who are lessees face multiple factors that apply significant pressure on rent costs, including:

- the housing shortage, as demonstrated by the general decline in the rental property vacancy rate in Québec in 2022;
- the rising cost of living;
- the decreasing affordability of housing throughout Québec;
- the shortage of housing adapted to the needs of families;

THAT it also note the shortage of social housing throughout Québec intended for lower-income earners as well as the increasing obsolescence of a portion of these buildings;

THAT it acknowledge that a generation of Quebecers' access to property is currently compromised by the rising cost of property, the reduction in the number of housing starts, the increase in construction costs, the labour shortage in the construction sector and the increase in interest rates;

THAT it recognize that the many processes of the different government levels, including housing organizations, are too lengthy and complex, and that streamlining programs is necessary;

THAT, lastly, it demand that the Québec government take on this mission of the State by establishing a housing action plan to simultaneously address the availability of social housing, the affordability of rental housing and access to property.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Derraji, Official Opposition House Leader, together with Ms. Charest, Minister Responsible for Sports, Recreation and the Outdoors, Ms. Zaga Mendez (Verdun), Mr. Bérubé (Matane-Matapédia) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly celebrate Shawn Rodrigue-Lemieux's victory in the under-18 division of the World Youth Chess Championship held in Romania from 6 to 17 September;

THAT it proudly share this young Quebecer's achievement, a first for Canada, defeating opponents from 54 countries;

THAT it recognize Rodrigue-Lemieux's outstanding contribution to raising the profile of chess in Québec and internationally;

THAT it highlight that his achievement was made possible by wins against players from Denmark, Romania, Hungary, Greece, Germany, Kazakhstan and Spain; THAT it recognize that the impressive journey of this young adult is a model of dedication, excellence and discipline for our Québec nation.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Ms. Labrie (Sherbrooke), together with Mr. Carmant, Minister Responsible for Social Services, Ms. Prass (D'Arcy-McGee), Mr. Arseneau (Îles-de-la-Madeleine) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly mark the 33rd annual Suicide Prevention Week organized by the Association québécoise de prévention du suicide under the theme "Prevention is better than death";

THAT it recall that in Québec, three people take their own lives every day and more than 3,600 people are hospitalized every year for a suicide attempt;

THAT it underscore the importance of prevention and the importance of encouraging people to dare to talk about suicide despite their fears or discomfort;

THAT it invite everyone to reach out, break the silence and normalize seeking help, because taking action can make a difference.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Bérubé (Matane-Matapédia), together with Mr. Julien, Minister Responsible for the Capitale-Nationale Region, Mr. Tanguay, Leader of the Official Opposition, Mr. Zanetti (Jean-Lesage) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly recall that the *Charter of Ville de Québec, national capital of Québec* provides that the territory of Ville de Québec is the ideal and preferred setting for welcoming foreign dignitaries to Québec, for diplomatic meetings and government summits and for major political meetings and important negotiations of all kinds in which the Québec government takes part;

THAT, to that end, it urge the Government to prioritize the territory of the national capital of Québec for holding such events in the future;

THAT it demand that the Secrétariat à la Capitale-Nationale record information on these events and meetings in its annual report, including where they were held.

The question was put on this motion, and a recorded division was thereupon demanded.

THAT it take note of the different measures being implemented to provide earlier diagnosis, particularly rapid investigation clinics for cancer;

THAT it underline the work of all those who mobilized for World Cancer Day;

THAT, lastly, it thank every person committed to providing cancer care and services and that it recognize the importance of their work.
