Debate on the Budget Speech

The Assembly resumed the debate, which had been adjourned on 23 March 2023, on the motion moved by Mr. Girard, Minister of Finance, and on the motions stating a grievance moved by Mr. Beauchemin (Marguerite-Bourgeoys), Mr. Bouazzi (Maurice-Richard), Mr. Tanguay, Leader of the Official Opposition, Mr. Zanetti (Jean-Lesage) and Ms. Dufour (Mille-Îles), subject to the receivability of these motions.

At the end of her address, Ms. Caron (La Pinière) moved the following motion stating a grievance:

THAT the National Assembly severely censure the CAQ government for presenting a budget that continues to penalize persons age 60 and over with disabilities with respect to the benefit they receive from the Régie des rentes du Québec.

The debate continued on the motion moved by Mr. Girard, Minister of Finance, and on the motions stating a grievance moved by Mr. Beauchemin (Marguerite-Bourgeoys), Mr. Bouazzi (Maurice-Richard), Mr. Tanguay, Leader of the Official Opposition, Mr. Zanetti (Jean-Lesage), Ms. Dufour (Mille-Îles) and Ms. Caron (La Pinière), subject to the receivability of these motions.

At 12:00 p.m., Mr. Lévesque, Second Vice-President, suspended the proceedings until 1:40 p.m.

Accordingly, pursuant to Standing Order 52, the debate on the motion moved by Mr. Girard, Minister of Finance, and on the motions stating a grievance moved by Mr. Beauchemin (Marguerite-Bourgeoys), Mr. Bouazzi (Maurice-Richard), Mr. Tanguay, Leader of the Official Opposition, Mr. Zanetti (Jean-Lesage), Ms. Dufour (Mille-Îles) and Ms. Caron (La Pinière), subject to the receivability of these motions, was adjourned.

The proceedings resumed at 1:40 p.m.

Oral Questions and Answers

The President issued a directive on modifications in the distribution of certain measures and speaking times having become necessary following modifications in the composition of the Assembly.

RULING FROM THE CHAIR

The Chair recalls that an agreement was reached at the beginning of the legislature between the different political parties represented in the Assembly on, in particular, the distribution of measures and the allocation of speaking times during limited debates. However, as has happened in the past, an amendment to this agreement was made necessary due to the election of the Member for Saint-Henri–Sainte-Anne, a member of the Second Opposition Group.

Following this election, the Official Opposition and the Second Opposition Group began negotiations with a view to agreeing on the modifications to be made to the agreement. They informed the Chair of their conclusions. Given that they are in keeping with the principles established by our parliamentary jurisprudence, the Chair is following up on this new agreement, which reflects the consensus reached by the two groups. The President specified that the new measures granted to the Second Opposition Group all originate from those previously granted to the Official Opposition. The modifications announced therefore have no impact on the rights granted to the Third Opposition Group or to independent Members. The Second Opposition Group will therefore be allocated three additional questions per 10-sitting cycle, in 6th place, at the 3rd, 7th and 9th sitting of a cycle.

This group will also be granted one additional item during Business Standing in the Name of Members in Opposition and one additional interpellation per two 14-sitting cycles, in 8th place.

The Second Opposition Group will also be granted one additional Statement by Members per 10-sitting cycle, in 6th place, at the 5th sitting of a cycle.

Lastly, the allocation of speaking times during limited debates are adjusted.

Motions Without Notice

Ms. Ghazal, Whip of the Second Opposition Group, together with Mr. Lacombe, Minister of Culture and Communications, Mr. Ciccone (Marquette), Ms. Tardif (Laviolette–Saint-Maurice) and Ms. Nichols (Vaudreuil), moved a motion on the increase in threats against elected officials; this motion could not be debated for want of unanimous consent.

Mr. Bérubé (Matane-Matapédia), together with Mr. Cliche-Rivard (Saint-Henri– Sainte-Anne), moved a motion on Québec's role in immigration within its borders; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Roberge, Minister Responsible for Canadian Relations and the Canadian Francophonie, together with Mr. Bérubé (Matane-Matapédia) and Ms. Tardif (Laviolette–Saint-Maurice), moved:

THAT the National Assembly take note of the closure of Roxham Road;

THAT it recall the importance that Québec's reception capacity be respected;

THAT, lastly, the National Assembly ask the federal government to distribute asylum seekers among all Canadian provinces and territories, taking into account the demographic weight and reception capacity of each in the integration effort.

By leave of the Assembly, the motion was carried.

Mr. Derraji, Official Opposition House Leader, together with Ms. Ghazal, Whip of the Second Opposition Group, Mr. Bérubé (Matane-Matapédia) and Ms. Nichols (Vaudreuil), moved a motion on the state of Québec's school infrastructure; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Lévesque, Deputy Government House Leader, moved:

THAT the National Assembly give effect to the order of reference given to the Committee on Institutions within the framework of the consideration of Bill 14, An Act to amend various provisions relating to public security and to enact the Act to assist in locating missing persons, to hold special consultations and public hearings on Tuesday, 4 April 2023 from 9:45 a.m. to 12:25 p.m. and after Notices of Proceedings in Committees from approximately 3:15 p.m. to 7:20 p.m.; on Wednesday, 5 April 2023 after Notices of Proceedings in Committees from approximately 11:15 a.m. to 12:50 p.m. and from 3:00 p.m. to 6:15 p.m.; and on Thursday, 6 April 2023 after Notices of Proceedings in Committees from 12:50 p.m. and from 2:00 p.m. to 4:25 p.m.;

THAT, for this purpose, the Committee hear the following individuals and organizations:

Fraternité des policiers et policières de Montréal Sûreté du Québec Association des directeurs de police du Québec Ligue des droits et libertés Service de police de la Ville de Montréal Association des policiers et policières provinciaux du Québec Fédération des policiers et policières municipaux du Québec Commission des droits de la personne et des droits de la jeunesse Association of Families of Persons Assassinated or Disappeared Commissaire à la déontologie policière Barreau du Québec Assembly of First Nations Quebec-Labrador Bureau des enquêtes indépendantes École nationale de police du Québec Fraternité des policiers et policières de la Ville de Québec Bureau du coroner Syndicat des agents de la paix en services correctionnels du Québec Coalition contre la répression et les abus policiers Comité consultatif sur la réalité policière;

THAT a period of 12 minutes be set aside for opening statements, allocated as follows: 6 minutes to the parliamentary group forming the Government, 3 minutes 36 seconds to the Official Opposition, 1 minute 12 seconds to the Second Opposition Group and 1 minute 12 seconds to the independent Member;

THAT the presentation by each organization last no longer than 10 minutes and the exchange with the Committee members last no longer than 35 minutes, allocated as follows: 17 minutes 30 seconds to the parliamentary group forming the Government, 10 minutes 30 seconds to the Official Opposition, 3 minutes 30 seconds to the Second Opposition Group and 3 minutes 30 seconds to the independent Member;

THAT a 5-minute interval be scheduled between discussions with each individual or organization;

THAT the Minister of Public Security be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Notices of Proceedings in Committees

Mr. Lévesque, Deputy Government House Leader, convened the following committee:

THAT the National Assembly censure the CAQ government for its 2023–2024 budget, which lacks ambition in the fight against climate change and which rolls out the red carpet to multinational corporations that are plundering our subsoil assets.

The debate continued on the motion moved by Mr. Girard, Minister of Finance, and on the motions stating a grievance moved by Mr. Beauchemin (Marguerite-Bourgeoys), Mr. Bouazzi (Maurice-Richard), Mr. Tanguay, Leader of the Official Opposition, Mr. Zanetti (Jean-Lesage), Ms. Dufour (Mille-Îles), Ms. Caron (La Pinière), Ms. Massé (Sainte-Marie–Saint-Jacques) and Ms. Zaga Mendez (Verdun), subject to the receivability of these motions.

At the beginning of his address, Mr. Leduc, Leader of the Second Opposition Group, moved the following motion stating a grievance:

THAT the National Assembly severely censure the CAQ government for the lack of budgetary measures allowing the remuneration of all work internships within the State apparatus.

The debate continued on the motion moved by Mr. Girard, Minister of Finance, and on the motions stating a grievance moved by Mr. Beauchemin (Marguerite-Bourgeoys), Mr. Bouazzi (Maurice-Richard), Mr. Tanguay, Leader of the Official Opposition, Mr. Zanetti (Jean-Lesage), Ms. Dufour (Mille-Îles), Ms. Caron (La Pinière), Ms. Massé (Sainte-Marie–Saint-Jacques), Ms. Zaga Mendez (Verdun) and Mr. Leduc, Leader of the Second Opposition Group, subject to the receivability of these motions.

The debate was adjourned in the name of Ms. Garceau (Robert-Baldwin).
