BUSINESS HAVING PRECEDENCE

- (1) Pursuant to Standing Orders 275 and 276, continuation of the debate on the motion by the Minister of Finance, –That this Assembly approve the budgetary policy of the Government,

And on the motions stating a grievance moved by:

The Member for Marguerite-Bourgeois:

THAT the National Assembly severely censure the CAQ government for putting at risk the ability of future generations to finance the services to which they are entitled by reducing the deposits in the Generations Fund.

The Member for Maurice-Richard:

THAT the National Assembly censure the CAQ government for this budget that is unfair, irresponsible and lacking ambition for Québec.

The Leader of the Official Opposition:

THAT the National Assembly severely censure the CAQ government for tabling a 2023–2024 budget that does not include a comprehensive plan to support the State’s essential missions, nor concrete measures to counter the labour shortage, in addition to abandoning future generations by reducing deposits in the Generations Fund.

The Member for Jean-Lesage:

THAT the National Assembly censure the CAQ government for the weakness of its orthodox stance on the Canadian Constitution, which prevents the Québec peoples from achieving their dreams of freedom.

The Member for Mille-Îles:

THAT the National Assembly severely censure the CAQ government for tabling a budget that does not help Québec families find housing, meet the expectations of housing organizations or support cities and municipalities to address their urgent and growing needs.

The Member for La Pinière:

THAT the National Assembly severely censure the CAQ government for presenting a budget that continues to penalize persons age 60 and over with disabilities with respect to the benefit they receive from the Régie des rentes du Québec.

The Member for Sainte-Marie–Saint-Jacques:

THAT the National Assembly severely censure the CAQ Government for its inability to offer the community sector working conditions commensurate with the services it provides to communities, while our social safety net is riddled with holes.

The Member for Verdun:

THAT the National Assembly censure the CAQ Government for its 2023–2024 budget, which lacks ambition in the fight against climate change and which rolls out the red carpet to multinational corporations that are plundering our subsoil assets.

The Member for Hochelaga-Maisonneuve:

THAT the National Assembly severely censure the CAQ Government for the lack of budgetary measures allowing the remuneration of all work internships within the State apparatus.

The Member for Robert-Baldwin:

THAT the National Assembly severely censure the CAQ government for planning to convert only 8% of all non-subsidized spaces in Québec into subsidized spaces.

The Member for Notre-Dame-de-Grâce:

THAT the National Assembly severely censure the CAQ government for its lack of ambition in its 2023–2024 budget, which does not contain sufficient investments to fully deal with the climate crisis and provide real and adequate protection for biodiversity and water in Québec.

The Member for Taschereau:

THAT the National Assembly censure the CAQ government for the unacceptable imbalance between investments in public transit and those in the road network in the 2023–2024 budget.

The Member for D’Arcy-McGee:

THAT the National Assembly severely censure the CAQ Government for its 2023–2024 budget, which does not address the current social crises, particularly mental health and homelessness, and which does not sufficiently take into account the needs of persons with disabilities or autism spectrum disorder.

The Member for Mercier:

THAT the National Assembly severely censure the Coalition avenir Québec government for its 2023–2024 budget, which does not meet the huge challenges in the education system that are undermining student success, such as the labour shortage, the dilapidated schools and the three-tiered system causing school segregation.

The Member for Pontiac:

THAT the National Assembly severely censure the CAQ government for its fifth consecutive budget, which does not include any funding to implement a safe nurse-to-patient ratio in the health and social services network.

The Member for Sherbrooke:

THAT the National Assembly censure the Coalition avenir Québec government for its budget, which does not provide the sums necessary to address the mental health crisis.

The Member for Laurier-Dorion:

THAT the National Assembly censure the CAQ government for its 2023–2024 budget, which heralds the end of social housing development in Québec and the privatization of public investments in housing.
