Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

At the request of the President, Mr. Legault, Premier, withdrew certain words deemed unparliamentary.

By leave of the Assembly to set aside Standing Orders 53 and 59, Ms. Cadet (Bourassa-Sauvé) tabled the following:

A series of decisions rendered by the occupational health and safety division of the Administrative Labour Tribunal regarding disputes concerning cases of occupational disease.

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 30 May 2023, on the motion moved by Mr. Dubé, Minister of Health, that Bill 15, An Act to make the health and social services system more effective, do now pass in principle.

The motion was carried on the following vote:

(Division No. 104 in Appendix)

Yeas: 88 Nays: 29 Abstentions: 0

Accordingly, Bill 15 was passed in principle.

Mr. Lévesque, Deputy Government House Leader, moved that Bill 15 be referred to the Committee on Health and Social Services for clause-by-clause consideration.

The motion was carried.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Drainville, Minister of Education, together with Ms. Rizqy (Saint-Laurent), Ms. Ghazal (Mercier), Mr. Bérubé (Matane-Matapédia) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly mark Education Staff Recognition Day, which was observed yesterday, 30 May;

THAT it reiterate that school staff are important for the development and well-being of preschool, elementary-school and high-school students, and also vocational-training and adult general-education students;

THAT it reaffirm and recognize that all school staff have a key role not only in students' educational success, but also in the future of Québec society as a whole.

By leave of the Assembly, the motion was carried.

Ms. Prass (D'Arcy-McGee), together with Ms. Labrie (Sherbrooke), Mr. Arseneau (Îles-de-la-Madeleine) and Ms. Nichols (Vaudreuil), moved a motion on the Agir tôt speech therapy program; this motion could not be debated for want of unanimous consent.

Mr. Bouazzi (Maurice-Richard), together with Mr. St-Pierre Plamondon, Leader of the Third Opposition Group, moved a motion on the natural gas delivered by the company Énergir; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Bérubé (Matane-Matapédia), together with Ms. Fréchette, Minister of Immigration, Francization and Integration, Mr. Derraji, Official Opposition House Leader, Mr. Cliche-Rivard (Saint-Henri–Sainte-Anne) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly strongly condemn Immigration, Refugees and Citizenship Canada's discrimination against francophone foreign students, in particular those from Africa, and that it urge the federal government to address this seriously and without delay.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Lévesque, Deputy Government House Leader, moved:

THAT, within the framework of the consideration of Bill 26, An Act to amend the Courts of Justice Act to, in particular, give effect to the agreement between the chief judge of the Court of Québec and the Minister of Justice, the Committee on Institutions hold special consultations and public hearings on Thursday, 1 June 2023 from 3:20 p.m. to 6:00 p.m. and from 7:30 p.m. to 9:55 p.m.;

THAT, for this purpose, the Committee hear the following individuals and organizations:

Mr. Patrick Taillon, Full Professor, Université Laval Association de défense des droits individuels et collectifs du Québec

Mr. Pierre Noreau, Law Professor, Université de Montréal

Association québécoise des avocats et avocates de la défense

Barreau du Ouébec

Ms. Martine Valois, Professor, Faculty of Law, Université de Montréal:

THAT a period of 12 minutes be set aside for opening statements, allocated as follows: 6 minutes to the parliamentary group forming the Government, 3 minutes 36 seconds to the Official Opposition, 1 minute 12 seconds to the Second Opposition Group and 1 minute 12 seconds to the independent Member;

THAT the presentation by each individual or organization last no longer than 10 minutes and the exchange with the Committee members last no longer than 35 minutes, allocated as follows: 17 minutes 30 seconds to the parliamentary group forming the Government, 10 minutes 30 seconds to the Official Opposition, 3 minutes 30 seconds to the Second Opposition Group and 3 minutes 30 seconds to the independent Member;

THAT a 5-minute interval be scheduled between discussions with each individual or organization;

THAT the Minister of Justice be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Notices of Proceedings in Committees

Mr. Lévesque, Deputy Government House Leader, convened the following committees:

- the Committee on Public Finance, to hold public hearings within the framework of special consultations on the report on the implementation of the Act to facilitate the disclosure of wrongdoings relating to public bodies;
- the Committee on Institutions, to continue its clause-by-clause consideration of Bill 14, An Act to amend various provisions relating to public security and to enact the Act to assist in locating missing persons;
- the Committee on Health and Social Services, to undertake clause-byclause consideration of Bill 15, An Act to make the health and social services system more effective;
- the Committee on Labour and the Economy, to undertake clause-by-clause consideration of Bill 25, An Act to fight illegal tourist accommodation;
- the Committee on Transportation and the Environment, to continue its clause-by-clause consideration of Bill 20, An Act to establish the Blue Fund and to amend other provisions;

— the Committee on Planning and the Public Domain, to hear the interested parties and undertake clause-by-clause consideration of these private bills in the following order: Bill 200, An Act respecting the cancellation of a servitude encumbering certain lots situated in Ville de Carignan; Bill 202, An Act respecting Ville de Saint-Jérôme.

ORDERS OF THE DAY

Government Bills

Passage

Mr. Jolin-Barrette, Minister of Justice, moved the passage of Bill 12, An Act to reform family law with regard to filiation and to protect children born as a result of sexual assault and the victims of that assault as well as the rights of surrogates and of children born of a surrogacy project.

After debate thereon, the motion was carried and, accordingly, Bill 12 was passed.

Report Stage

The Assembly took into consideration the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 19, An Act respecting the regulation of work by children.

A debate arose thereon.

At $1:00\,$ p.m., Mr. Benjamin, Third Vice-President, suspended the proceedings until $3:00\,$ p.m.

The proceedings resumed at 3:00 p.m.

The Assembly continued the debate on the consideration of the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 19, An Act respecting the regulation of work by children.

The debate being concluded, the report was concurred in.

Passage

Mr. Girard, Minister of Finance, informed the Assembly that the Honourable J. Michel Doyon, Lieutenant-Governor of Québec, recommended Bill 7, An Act respecting the implementation of certain provisions of the Budget Speech of 22 March 2022 and amending other legislative provisions, for its consideration, and then moved that this bill do now pass.

After debate thereon, the motion was carried on division and, accordingly, Bill 7 was passed.

Report Stage

The Assembly took into consideration the report from the Committee on Planning and the Public Domain on its clause-by-clause consideration of Bill 16, An Act to amend the Act respecting land use planning and development and other provisions, together with the amendment transmitted by Ms. Dufour (Mille-Îles).

The amendment was declared in order.

After debate thereon, by leave of the Assembly, Mr. Lévesque, Second Vice-President, read the text of the amendment proposed by Ms. Dufour (Mille-Îles) before the question was put on the amendment; and a recorded division was thereupon demanded.

At the request of Mr. Lévesque, Deputy Government House Leader, the divisions on the amendment proposed by Ms. Dufour (Mille-Îles) and the report from the Committee on Planning and the Public Domain were deferred until Routine Proceedings on the next sitting day.

Debates on Reports from Committees

The Assembly took into consideration the report from the Committee on Culture and Education, which held public hearings on 22 February and on 21, 22 and 23 March 2023 within the framework of special consultations on the order of initiative on the revelations of violence during hazing in the junior hockey league and the potential situation in other sports. The report contains 23 recommendations.

Mr. Lévesque, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 60 minutes to the parliamentary group forming the Government; 31 minutes 36 seconds to the parliamentary group forming the Official Opposition; 20 minutes 54 seconds to the Second Opposition Group; 6 minutes to the Third Opposition Group; and 1 minute 30 seconds to the independent Member. Within this framework, any time not used by the independent Member or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate was adjourned in the name of Mr. Asselin (Vanier-Les Rivières).

At 6:00 p.m., Ms. Soucy, First Vice-President, adjourned the Assembly until Thursday, 1 June 2023 at 9:40 a.m.
