

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Arseneau (Îles-de-la-Madeleine), together with Mr. Dubé, Minister of Health, Mr. Fortin (Pontiac), Mr. Cliche-Rivard (Saint-Henri–Sainte-Anne), Ms. Nichols (Vaudreuil) and Mr. Beauchemin (Marguerite-Bourgeoys), moved:

THAT the National Assembly recognize that immunocompromised people are always vulnerable to bacteria, viruses and their variants;

THAT it acknowledge that, out of solidarity and respect for these people, it must increase public awareness of the challenges they face;

THAT it consider that a national day of immunocompromised people be established;

THAT, lastly, it recognize the slanted red "i" as the official symbol of prevention with regard to immunocompromised individuals, in order to encourage people to respect social distancing when they see someone wearing this symbol.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Ms. Guilbault, Minister of Transport and Sustainable Mobility, together with Mr. Morin (Acadie), Mr. Grandmont (Taschereau), Mr. Arseneau (Îles-de-la-Madeleine), Ms. Nichols (Vaudreuil) and Mr. Beauchemin (Marguerite-Bourgeoys), moved:

THAT the Assembly underline the 40th anniversary of Operation Red Nose;

THAT it recognize the importance of this non-profit organization in preventing impaired driving;

THAT it recognize that Operation Red Nose has greatly contributed to making our roads safer over the years;

THAT it underline the Québec government's unwavering commitment as Operation Red Nose's main partner since its creation;

THAT, lastly, it thank all the volunteers who have participated in Operation Red Nose over the past four decades.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Ms. Cadet (Bourassa-Sauvé), together with Mr. Roberge, Minister of the French Language, Ms. Ghazal (Mercier), Mr. Bérubé (Matane-Matapédia), Ms. Nichols (Vaudreuil) and Mr. Beauchemin (Marguerite-Bourgeoys), moved:

THAT the National Assembly take note that, for more than 25 years, the "Parlez-moi d'une langue!" program has enabled hundreds of speakers to meet tens of thousands of students in college, university and adult education institutions every year to share with them the importance of the French language and reaffirm their desire to speak, write and live in French;

THAT it underline that this program helps promote and enhance the quality of written and spoken French for young Quebecers throughout the regions;

THAT it emphasize that this program is a direct result of the government priorities set out in the language policy to promote the use of the French language and improve its quality in all sectors of activity of Québec society;

THAT it declare that the continuation of this program is highly desirable for the protection and promotion of the French language in Québec and for the sharing and development of Québec culture;

THAT, lastly, it ask the Québec government to renew the funding for the "Parlez-moi d'une langue!" program without delay.

The question was put on this motion, and an electronic division was thereupon demanded.

The motion was carried on the following vote:

- the Committee on Health and Social Services, to continue its clause-byclause consideration of Bill 15, An Act to make the health and social services system more effective;

- the Committee on Planning and the Public Domain, to continue its clauseby-clause consideration of Bill 31, An Act to amend various legislative provisions with respect to housing;
- the Committee on Transportation and the Environment, to continue its clause-by-clause consideration of Bill 22, An Act respecting expropriation.

ORDERS OF THE DAY

Government Bills

Passage

Mr. Carmant, Minister Responsible for Social Services, moved the passage of Bill 36, Opioid-related Damages and Health Care Costs Recovery Act.

After debate thereon, the motion was carried and, accordingly, Bill 36 was passed.

At 11:35 a.m., at the request of Mr. Lévesque, Deputy Government House Leader, Ms. Soucy, First Vice-President, suspended the proceedings until 3:00 p.m.

The proceedings resumed at 3:00 p.m.

Business Standing in the Name of Members in Opposition

Ms. Rizqy (Saint-Laurent) moved:

THAT the National Assembly acknowledge that the proposed changes to the tuition fees for out-of-province Canadian students will decrease the economic benefits generated by their presence in Québec, hinder the development of certain Québec universities and promote the development of universities elsewhere in Canada, notably in Toronto;

THAT it note that no impact study supports this decision and that it is risky to claim, as the Government does, that this measure will help recover additional sums to fund the university network:

THAT, lastly, it ask the CAQ government to reconsider this measure.

Mr. Benjamin, Third Vice-President, informed the Assembly of the allocation of speaking time with respect to this limited debate: 10 minutes to the mover of the motion for her reply; 53 minutes 30 seconds to the parliamentary group forming the Government; 28 minutes 19 seconds to the parliamentary group forming the Official Opposition; 18 minutes 53 seconds to the Second Opposition Group; 6 minutes 18 seconds to the Third Opposition Group; and 1 minute 30 seconds to each independent Member. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At the request of Mr. Benjamin, Third Vice-President, Ms. Rizqy (Saint-Laurent) withdrew certain words deemed unparliamentary.

At the beginning of his address, Mr. Leduc (Hochelaga-Maisonneuve) moved:

THAT the motion moved by the Member for Saint-Laurent be amended as follows:

By adding the following paragraph after the second paragraph:

"THAT it note that the 2018 decision to deregulate tuition fees for international students was bad public policy;".

The motion, as amended, would read as follows:

THAT the National Assembly acknowledge that the proposed changes to the tuition fees for out-of-province Canadian students will decrease the economic benefits generated by their presence in Québec, hinder the development of certain Québec universities and promote the development of universities elsewhere in Canada, notably in Toronto;

THAT it note that no impact study supports this decision and that it is risky to claim, as the Government does, that this measure will help recover additional sums to fund the university network;

THAT it note that the 2018 decision to deregulate tuition fees for international students was bad public policy;

THAT, lastly, it ask the CAQ government to reconsider this measure.

THAT it ask the CAQ government to start catching up on funding for French-language universities as of the 2024–2025 budget;

THAT, lastly, it ask the CAQ government to reconsider this measure.

The debate continued on the main motion moved by Ms. Rizqy (Saint-Laurent) and on the amendment motions moved by Mr. Leduc (Hochelaga-Maisonneuve), subject to the permission of its author.

Pursuant to Standing Order 98.1, Ms. Rizqy (Saint-Laurent) refused the amendments proposed by Mr. Leduc (Hochelaga-Maisonneuve).

The debate being concluded, the question was put on this motion, and an electronic division was thereupon demanded.

At the request of Mr. Lévesque, Deputy Government House Leader, the division on the motion moved by Ms. Rizqy (Saint-Laurent) was deferred until Routine Proceedings on the next sitting day.

Mr. Lévesque, Deputy Government House Leader, moved the adjournment of the Assembly until Thursday, 2 November 2023 at 9:40 a.m.

The motion was carried.

At 5:00 p.m., Mr. Benjamin, Third Vice-President, adjourned the Assembly until Thursday, 2 November 2023 at 9:40 a.m.
