

**AMENDMENT NUMBER 4
TO THE AGREEMENT ON THE PROVISION OF POLICING SERVICES
IN THE COMMUNITY OF KITIGAN ZIBI
FROM APRIL 1ST, 2018 TO MARCH 31ST, 2028**

AMONG: **THE COUNCIL OF THE KITIGAN ZIBI ANISHINABEG**
represented by the Chief
(hereinafter referred to as the "Council")

(hereinafter referred to as "Québec")

(hereinafter collectively referred to as the "Parties")

PREAMBLE

WHEREAS the Parties entered into an Agreement on August 23, 2018, entitled Agreement on the Provision of Policing Services in the Community of Kitigan Zibi for the period from April 1st, 2018 to March 31st, 2028 (hereinafter called the "Agreement");

WHEREAS, where applicable, the Agreement includes any previous amendments made by way of an amendment signed by the Parties;

WHEREAS the Parties wish to amend the Agreement, in accordance with subsection 6.3 of this Agreement, in order to support the stabilization of the provision of policing services;

WHEREAS this Amendment aims to increase the operational budget of the Kitigan Zibi Police Force as of Fiscal Year 2022-2023;

CONSEQUENTLY, the parties agree as follows:

1. The Preamble and Schedule A form an integral part of this Amendment.
2. All terms and conditions of the Agreement remain unchanged except as provided in this Amendment.
3. Subparagraph 4.2.1 b) of the Agreement is replaced by the following:
 - b) in accordance with the budget in Schedule A (Police Service Budget) of this Agreement, at:
 - \$ 1,195,396 for Fiscal Year 2018-2019;
 - \$ 1,228,269 for Fiscal Year 2019-2020;
 - \$ 1,779,938.41 for Fiscal Year 2020-2021, of which a maximum of \$ 381,416.41 is for expenditures related to COVID-19;
 - \$ 1,766,981 for Fiscal Year 2021-2022, of which a maximum of \$ 330,000 is for expenditures related to COVID-19;

\$ 1,572,470 for Fiscal Year 2022-2023;
\$ 1,615,713 for Fiscal Year 2023-2024;
\$ 1,660,145 for Fiscal Year 2024-2025;
\$ 1,705,799 for Fiscal Year 2025-2026;
\$ 1,752,708 for Fiscal Year 2026-2027;
\$ 1,800,907 for Fiscal Year 2027-2028;

totaling \$ 16,078,326.41 for the agreement as a whole.

4. Subparagraphs 4.2.2 e), f), g), h), i) and j) of the Agreement are replaced by the following:

- e) for Fiscal Year 2022-2023:
\$ 817,684 for Canada;
\$ 754,786 for Québec.
- f) for Fiscal Year 2023-2024:
\$ 840,171 for Canada;
\$ 775,542 for Québec.
- g) for Fiscal Year 2024-2025:
\$ 863,275 for Canada;
\$ 796,870 for Québec.
- h) for Fiscal Year 2025-2026:
\$ 887,015 for Canada;
\$ 818,784 for Québec.
- i) for Fiscal Year 2026-2027:
\$ 911,408 for Canada;
\$ 841,300 for Québec.
- j) for Fiscal Year 2027-2028:
\$ 936,472 for Canada;
\$ 864,435 for Québec.

5. Fiscal Years 2022-2023 to 2027-2028 of the Agreement is replaced by Schedule A attached to this Amendment.

6. Paragraph 4.5.1 is replaced by the following:

4.5.1 The carryover of unexpended funding is subject to the following terms and conditions:

- a) With the written authorization of Canada and Québec, the Council may carry over any unexpended funding at the end of a fiscal year to the following fiscal year, with the exception of expenditures related to COVID-19, provided that they have been advanced the funding and the Council proposes to use the funds to cover eligible expenses listed in this Agreement or for purposes consistent with its objectives and activities. To obtain this written authorization, the Council shall provide Canada and Québec with a written notification;
- b) The notification shall describe how the Council plans to use the unexpended funding and include any information required by Canada and Québec, and shall be presented as per the Unexpended Funding Statement provided in Schedule D - Cash Flow Statement;
- c) Unexpended funding shall be clearly identified in the cash flow statement provided for in paragraph 4.3.1 and the annual audited financial statements provided for in paragraph 4.9.2. Any unexpended funding remaining upon expiry of this Agreement, unless renewed constitutes a debt due to Canada and Québec.

7. Schedules D and E from the Agreement are replaced by Schedule D attached to this amendment.
8. Any reference to Schedule E in the Agreement is a reference to Schedule D.
9. This Amendment may be executed in several counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument. Each Party will receive all signed copies; it being understood that all Parties need not sign the same counterparts.
10. The exchange of copies of this Amendment and of signature pages by electronic mail in "portable document format" (".pdf") form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, or by combination of such means, shall constitute effective execution and delivery of this Amendment as to the Parties and may be used in lieu of the original Amendment for all purposes.

WHEREAS this Amendment aims to increase the operational budget of the Kitigan Zibi Police Force as of Fiscal Year 2022-2023;

CONSEQUENTLY, the parties agree as follows:

1. The Preamble and Schedule A form an integral part of this Amendment.
2. All terms and conditions of the Agreement remain unchanged except as provided in this Amendment.
3. Subparagraph 4.2.1 b) of the Agreement is replaced by the following:
 - b) in accordance with the budget in Schedule A (Police Service Budget) of this Agreement, at:
 - \$ 1,195,396 for Fiscal Year 2018-2019;
 - \$ 1,228,269 for Fiscal Year 2019-2020;
 - \$ 1,779,938.41 for Fiscal Year 2020-2021, of which a maximum of \$ 381,416.41 is for expenditures related to COVID-19;
 - \$ 1,766,981 for Fiscal Year 2021-2022, of which a maximum of \$ 330,000 is for expenditures related to COVID-19;

\$ 1,572,470 for Fiscal Year 2022-2023;
\$ 1,615,713 for Fiscal Year 2023-2024;
\$ 1,660,145 for Fiscal Year 2024-2025;
\$ 1,705,799 for Fiscal Year 2025-2026;
\$ 1,752,708 for Fiscal Year 2026-2027;
\$ 1,800,907 for Fiscal Year 2027-2028;

totaling \$ 16,078,326.41 for the agreement as a whole.

4. Subparagraphs 4.2.2 e), f), g), h), i) and j) of the Agreement are replaced by the following:

- j) for Fiscal Year 2027-2028:
\$ 936,472 for Canada;
\$ 864,435 for Québec.

5. Fiscal Years 2022-2023 to 2027-2028 of the Agreement is replaced by Schedule A attached to this Amendment.

6. Paragraph 4.5.1 is replaced by the following:

4.5.1 The carryover of unexpended funding is subject to the following terms and conditions:

- a) With the written authorization of Canada and Québec, the Council may carry over any unexpended funding at the end of a fiscal year to the following fiscal year, with the exception of expenditures related to COVID-19, provided that they have been advanced the funding and the Council proposes to use the funds to cover eligible expenses listed in this Agreement or for purposes consistent with its objectives and activities. To obtain this written authorization, the Council shall provide Canada and Québec with a written notification;
- b) The notification shall describe how the Council plans to use the unexpended funding and include any information required by Canada and Québec, and shall be presented as per the Unexpended Funding Statement provided in Schedule D - Cash Flow Statement;
- c) Unexpended funding shall be clearly identified in the cash flow statement provided for in paragraph 4.3.1 and the annual audited financial statements provided for in paragraph 4.9.2. Any unexpended funding remaining upon expiry of this Agreement, unless renewed constitutes a debt due to Canada and Québec.

7. Schedules D and E from the Agreement are replaced by Schedule D attached to this amendment.
8. Any reference to Schedule E in the Agreement is a reference to Schedule D.
9. This Amendment may be executed in several counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument. Each Party will receive all signed copies; it being understood that all Parties need not sign the same counterparts.
10. The exchange of copies of this Amendment and of signature pages by electronic mail in “portable document format” (“.pdf”) form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, or by combination of such means, shall constitute effective execution and delivery of this Amendment as to the Parties and may be used in lieu of the original Amendment for all purposes.
