

Government Bills

Passage in Principle

By leave of the Assembly to set aside Standing Order 236, Mr. Jolin-Barrette, Minister of Justice, moved that Bill 54, An Act to follow up on the Table Justice-Québec with a view to reducing processing times in criminal and penal matters and to make the administration of justice more efficient, do now pass in principle.

The debate being concluded, the motion was carried and Bill 54 was accordingly passed in principle.

Mr. Lévesque, Deputy Government House Leader, moved that Bill 54 be referred to the Committee on Institutions for clause-by-clause consideration.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Transportation and the Environment on its clause-by-clause consideration of Bill 41, An Act to enact the Act respecting the environmental performance of buildings and to amend various provisions regarding energy transition, together with the amendments transmitted by Ms. Dufour (Mille-Îles) and Ms. Zaga Mendez (Verdun).

The amendments were declared in order.

A debate arose thereon.

Pursuant to Standing Order 100, Mr. Lévesque, Deputy Government House Leader, moved the adjournment of the debate.

The motion was carried.

Accordingly, the debate on the motion moved by Mr. Jolin-Barrette, Minister of Justice, was adjourned.

THAT, pursuant to Standing Order 280, the 2024–2025 estimates of expenditure be referred to a Committee of the Whole for consideration and for concurrence in one quarter of the said estimates.

Mr. Jolin-Barrette, Government House Leader, moved:

THAT, pursuant to the provisions of subparagraph 4.1 of the first paragraph of Standing Order 87 and Standing Orders 280 and 281, the Assembly consider and concur in Interim Supply for the 2024–2025 fiscal year as provided hereinafter; THAT, as soon as Orders of the Day for the 13 March 2024 sitting are called, the Assembly resolve itself into a Committee of the Whole and consider Interim Supply as follows:

THAT, for a period not exceeding 1 hour, an exchange take place between the Minister Responsible for Government Administration and Chair of the Conseil du trésor and the Members in opposition;

THAT, immediately thereafter, for a period not exceeding 1 hour, an exchange take place between the Minister Responsible for the Capitale-Nationale Region and the Members in Opposition;

THAT, immediately thereafter, the Committee of the Whole suspend its proceedings and that the proceedings of the Assembly be suspended until 3:00 p.m.;

THAT, at 3:00 p.m., for a period not exceeding 1 hour 30 minutes, an exchange take place between the Minister of Transport and Sustainable Mobility and the Members in Opposition;

THAT, immediately thereafter, for a period not exceeding 1 hour 30 minutes, an exchange take place between the Minister of Health and the Members in Opposition;

THAT, immediately upon the conclusion of this exchange, the Chair of the Committee on the Whole put the question for concurrence in one quarter of the estimates of expenditure for the 2024–2025 fiscal year;

THAT the Chair of the Committee of the Whole then report to the Assembly and that the question for concurrence in such report and then the question for passage of the consequent appropriation bill be put without debate, pursuant to the first paragraph of Standing Order 281;

THAT, lastly, pursuant to the second paragraph of Standing Order 281, the Government House Leader be permitted to move a motion without notice that may not be debated, stating that the main estimates of expenditure, save those of the National Assembly, be referred to the Standing Committees for consideration; THAT the opening statements for each of the exchanges with the Minister Responsible for Government Administration and Chair of the Conseil du trésor and the Minister Responsible for the Capitale-National Region not exceed 6 minutes for the parliamentary group forming the Government, 2 minutes 59 seconds for the parliamentary group forming the Official Opposition, 1 minute 58 seconds for the Second Opposition Group, 40 seconds for the Third Opposition Group and 24 seconds for the independent Member;

THAT the opening statements for each of the exchanges with the Minister of Transport and Sustainable Mobility and the Minister of Health not exceed 9 minutes for the parliamentary group forming the Government, 4 minutes 28 seconds for the parliamentary group forming the Official Opposition, 2 minutes 57 seconds for the Second Opposition Group, 1 minute for the Third Opposition Group and 36 seconds for the independent Member;

THAT, for each of the exchanges with the aforementioned Ministers, a period of 45 seconds per hour be set aside for exchanges with the independent Member;

THAT any time not used by the independent Member be redistributed proportionally among the parliamentary groups forming the Official Opposition, the Second Opposition Group and the Third Opposition Group;

THAT the President of the Assembly or the Chair of the Committee of the Whole be permitted to suspend the proceedings at any time;

THAT, despite Standing Order 20, the Committee of the Whole and the Assembly be permitted to continue their proceedings until the latter has voted on the appropriation bill and on the motion for referral of all of the estimates of expenditure, save those of the National Assembly, to the Standing Committees for consideration; THAT this motion become an order of the Assembly and take precedence over any incompatible provisions of the Standing Orders.

Motions Without Notice

THAT the National Assembly underline Camille Laurin's considerable contribution and decisive role in the defence and promotion of the French language in Québec;

THAT it recall that Camille Laurin, in his capacity as psychiatrist, politician and intellectual father of the Charter of the French language, significantly contributed to the preservation of the linguistic and cultural identity of the Québec nation;

THAT it affirm that the Charter of the French language remains a cornerstone of the protection and promotion of French as an official and common language in Québec;

THAT, on the 25th anniversary of his death, the National Assembly pay tribute to this great Quebecer for his unwavering commitment to the French language and his exceptional contribution to the preservation of Québec identity.

THAT it vigorously condemn gang rapes and other acts of sexual violence perpetrated by armed gangs to inflict terror, punishment and humiliation on local populations;

THAT it recall that, last October, Québec unveiled a support plan for Haiti to help vulnerable populations and implement measures in favour of education, justice, security and local governance;

THAT the National Assembly ask the Québec Government to support the federal government's actions to increase efforts to ensure stability and put an end to violence in Haiti, so that Haitians can rebuild their country in peace and security;

THAT, lastly, it applaud the courage and resilience of the Haitian people and civil society organizations in the face of this situation.
