

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

Mr. Roberge, Minister Responsible for Laicity, together with Mr. Bérubé (Matane-Matapédia), moved a motion on laicity; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Ms. Prass (D'Arcy-McGee), together with Mr. Carmant, Minister Responsible for Social Services, Mr. Cliche-Rivard (Saint-Henri–Sainte-Anne). Mr. Arseneau (Îles-de-la-Madeleine) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly recognize that opioid overdose is a public health crisis;

THAT it acknowledge that this crisis is causing an alarming rise in the number of deaths and putting additional pressure on our health system;

THAT, lastly, it ask the Québec government to implement any additional measures to protect the public from this scourge and contain the epidemic, such as providing equipment for analyzing drug composition to prevent overdoses, and that it do so as soon as possible.

The question was put on this motion, and an electronic division was thereupon demanded.

THAT the National Assembly recognize the impact of inflation on public service workers;

THAT it recall that these workers have not received a pay raise since March 2023;

THAT it underline that several elements of the agreement in principle, in particular the increases in evening and night allowances as well as weekend overtime, are not retroactive and will only be applicable upon signature of the collective agreement;

THAT, therefore, it ask the Government to pay the bonuses and salary increases contained in the agreements in principle as soon as possible.
