

Appropriation Bills

By leave of the Assembly, Ms. LeBel, Minister Responsible for Government Administration and Chair of the Conseil du trésor, moved the introduction, passage in principle and passage of Bill 58, Appropriation Act No. 2, 2024–2025.

The motion was carried on the following vote:

Accordingly, Bill 58, Appropriation Act No. 2, 2024–2025, was passed.

Deferred Divisions

The Assembly took the division, which had been deferred on 1 May 2024, on the motion moved by Mr. Marissal (Rosemont) during Business Standing in the Name of Members in Opposition.

This motion reads as follows:

THAT the National Assembly recognize that the longterm viability and quality of health care in Québec requires a strong public health system with the means to attract and retain caregivers.

The motion was carried on the following vote:

Yeas: 109 Nays: 0 Abstentions: 0

The Assembly took the division, which had been deferred at the sitting of 1 May 2024, on the motion moved by Mr. Roberge, Minister Responsible for Laicity, for the passage of Bill 52, An Act to enable the Parliament of Québec to preserve the principle of parliamentary sovereignty with respect to the Act respecting the laicity of the State.

The motion was carried on the following vote:

Yeas: 83 Nays: 26 Abstentions: 0

Accordingly, Bill 52 was passed.

Motions Without Notice

Mr. Jolin-Barrette, Minister of Justice, together with Mr. Paradis (Jean-Talon), moved a motion on the provisions on parliamentary sovereignty; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Ciccone (Marquette), together with Mr. Lacombe, Minister of Culture and Communications, Mr. Zanetti (Jean-Lesage), Mr. Bérubé (Matane-Matapédia), Ms. Nichols (Vaudreuil) and Mr. Lefebvre (Arthabaska), moved:

THAT the National Assembly pay tribute to Paul Houde, who passed away on 2 March 2024;

THAT it underline the prolific career of this man who charmed the world of radio, television and cinema;

THAT it underline his phenomenal memory, his encyclopedic knowledge of myriad topics, his remarkable learning, his love of the French language, and his contribution to the promotion and visibility of Québec culture;

THAT it recall his involvement in the international Olympic movement through his coverage of various Olympic Games since 1976;

THAT it recall that he shared his numerous passions with Quebecers, in particular sports, aviation and astronomy, with an authentic and contagious drive and enthusiasm;

THAT it underline the deep affection Quebecers felt towards him for his great humanity, his impeccable professionalism and the hard work he put into every project;

THAT, lastly, it express its sincere condolences to his family and that it observe a minute of silence in memory of this great Quebecer.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

At the request of Mr. Benjamin, Third Vice-President, the Assembly observed a minute of silence.

Ms. Labrie (Sherbrooke), together with Mr. Paradis (Jean-Talon), moved a motion on the *Individual and Family Assistance Act*; this motion could not be debated for want of unanimous consent.

Mr. Arseneau (Îles-de-la-Madeleine), together with Mr. Grandmont (Taschereau), moved a motion on the stretch of Route 389 between Fire Lake and Fermont; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Caire, Deputy Government House Leader, convened the following committees:

- the Committee on Institutions, to continue its public hearings within the framework of special consultations on Bill 56, An Act respecting family law reform and establishing the parental union regime;
- the Committee on Labour and the Economy, to continue its clause-byclause consideration of Bill 51, An Act to modernize the construction industry;

- the Committee on Planning and the Public Domain, to continue its public hearings within the framework of special consultations on Bill 57, An Act to enact the Act to protect elected officers and to facilitate the unhindered exercise of their functions and to amend various legislative provisions concerning municipal affairs;
- the Committee on Planning and the Public Domain, to continue its clauseby-clause consideration of Bill 50, An Act to enact the Act respecting civil protection to promote disaster resilience and to amend various provisions relating in particular to emergency communication centres and to forest fire protection;
- the Committee on Health and Social Services, to continue its clause-byclause consideration of Bill 37, An Act respecting the Commissioner for Children's Well-Being and Rights;
- the Committee on Labour and the Economy, to continue its clause-byclause consideration of Bill 44, An Act to amend mainly the Act respecting the Ministère de l'Économie et de l'Innovation with respect to research.

Mr. Benjamin, Third Vice-President, gave the following notices:

- the Committee on Health and Social Services shall hold a deliberative meeting to hold advisory meetings within the framework of the order of initiative on examining ways to facilitate organ and tissue donation, in particular the adoption of presumed consent;
- the Committee on Agriculture, Fisheries, Energy and Natural Resources shall hold a deliberative meeting to discuss the possibility of carrying out an order of initiative on animal welfare.

By leave of the Assembly to set aside Standing Orders 298 and 299, Mr. Benjamin, Third Vice-President, informed the Assembly that the interpellation scheduled for Friday, 3 May 2024 between Mr. Fortin (Pontiac) and Mr. Lamontagne, Minister of Agriculture, Fisheries and Food, on Québec's agriculture neglected by the CAQ government will be held on Friday, 10 May 2024 from 10:00 a.m. to 12:00 p.m.

Government Bills

Passage in Principle

By leave of the Assembly to set aside Standing Orders 236 and 237, Mr. Roberge, Minister Responsible for Democratic Institutions, moved that Bill 59, An Act to interrupt the electoral division delimitation process, do now pass in principle.

By leave of the Assembly to set aside Standing Order 239, the question on this motion was put without debate.

The motion was carried, and Bill 59, An Act to interrupt the electoral divisions delimitation process, was accordingly passed in principle.

Mr. Caire, Deputy Government House Leader, moved that Bill 59 be referred to the Committee of the Whole for clause-by-clause consideration.

The motion was carried.

Mr. Caire, Deputy Government House Leader, moved that the Assembly resolve itself into a Committee of the Whole for clause-by-clause consideration of Bill 59, An Act to interrupt the electoral divisions delimitation process.

The motion was carried.

Committee of the Whole

Bill 59 was considered in Committee of the Whole and thereupon reported.

The report was concurred in.

Passage

By leave of the Assembly to set aside Standing Order 230, Mr. Roberge, Minister Responsible for Democratic Institutions, moved the passage of Bill 59, An Act to interrupt the electoral division delimitation process.

By leave of the Assembly to set aside Standing Order 256, the speaking times for this debate were limited to 10 minutes per parliamentary group.

A debate arose thereon.

The debate being concluded, the motion was carried and, accordingly, Bill 59 was passed.

Passage in Principle

Ms. LeBel, Minister Responsible for Government Administration and Chair of the Conseil du trésor, moved that Bill 60, An Act to authorize the making of collective agreements with a term of more than three years in the public and parapublic sectors, do now pass in principle.

After debate thereon, the motion was carried, and Bill 60 was accordingly passed in principle.

Mr. Caire, Deputy Government House Leader, moved that Bill 60 be referred to the Committee on Public Finance for clause-by-clause consideration.

The motion was carried.

Passage

Mr. Girard, Minister of Finance, moved the passage of Bill 49, An Act to give effect to fiscal measures announced in the Budget Speech delivered on 21 March 2023 and to certain other measures.

After debate thereon, the motion was carried on division and, accordingly, Bill 49 was passed.

At 11:45 a.m., at the request of Mr. Caire, Deputy Government House Leader, Mr. Benjamin, Third Vice-President, suspended the proceedings until 1:00 p.m.

Debates upon Adjournment

At 12:01 p.m., by leave of the Assembly to set aside Standing Order 309, the Assembly held a debate upon adjournment on a question from Mr. Beauchemin (Marguerite-Bourgeoys) to Mr. Girard, Minister of Finance, about the Coalition Avenir Québec's lack of results in public finance. Mr. Caire, Minister of Cybersecurity and Digital Technology, replaced the Minister for this debate.

Mr. Caire, Deputy Government House Leader, moved the adjournment of the Assembly until Tuesday, 7 May 2024 at 1:40 p.m.

The motion was carried.

Accordingly, at 12:14 p.m., Mr. Benjamin, Third Vice-President, adjourned the Assembly until Tuesday, 7 May 2024 at 1:40 p.m.
