Oral Questions and Answers

The President issued a directive on modifications in the distribution of certain measures and speaking times having become necessary following modifications in the composition of the Assembly, including the departure of the Members for Saint-Laurent and Chomedey from the parliamentary group forming the Official Opposition and the resignation of the Members for La Prairie and Dubuc from the parliamentary group forming the Government to sit as independent Members.

RULING FROM THE CHAIR

Firstly, the speaking times for limited debates shall be adjusted to reflect the changes made to the composition of the Assembly, as is customary.

As regards Statements by Members, the new independent Members will each be granted one statement per cycle of 10 sittings. The Members for Saint-Laurent and Chomedey will be granted a statement in 6th place, at the 3rd and 8th sittings of the cycle, respectively, to replace a statement by the parliamentary group forming the Official Opposition. As for the Members for La Prairie and Dubuc, they will be granted a statement in 10th place, at the 1st and 4th sittings of the cycle, respectively, to replace a statement by the parliamentary group forming the Government. It should be noted that independent Members who do not intend to exercise this right must inform their parliamentary group, as well as the Chair, not later than 12:30 p.m. on the day before the sitting during which the statement could be made.

3 February 2026

As regards question period, all independent Members who intend to exercise this measure will be granted three questions per two cycles of 12 sittings, in 8th place.

Questions of independent Members from a parliamentary opposition group will be in substitution to those from their original parliamentary group. However, for independent Members from the parliamentary group forming the Government, including those who had already been exercising this right, their questions will now be in substitution to those from the three parliamentary opposition groups, in proportion with their representation in the opposition.

Lastly, it should be noted that many changes were made concerning the order of questions in the cycle to allocate questions in 8th place to each independent Member.

THAT, lastly, the National Assembly observe a moment of silence to honour the memory of those who died.

THAT it note that the actions taken by the Government in recent years have not curbed the increase in violence against women, that this violence continues to increase, and that it is appropriate and necessary to enhance the policy framework in this regard;

THAT, lastly, it demand that the Government urgently table an update to the 2022–2027 government strategy to fight against sexual violence and domestic violence and to rebuild trust, which is based in particular on the predictability of funding for women’s shelters, increased shelter capacity and improved prevention, early detection and support services, including for women experiencing homelessness.
