By leave of the Assembly to set aside Standing Order 185, Mr. Arseneau (Îles-de-la-Madeleine), together with Ms. Bélanger, Minister of Health, Ms. Prass (D'Arcy-McGee), Mr. Grandmont (Taschereau), Mr. Carmant (Taillon), Ms. Poulet (Laporte), Mr. Marissal (Rosemont), Ms. Rizqy (Saint-Laurent) and Ms. Lakhoyan Olivier (Chomedey), moved:

THAT the National Assembly mark the 36th annual Suicide Prevention Week organized by the Association québécoise de prévention du suicide under the theme "Reach out, support hope";

THAT it acknowledge the fact that three people take their own lives every day and that suicide attempts reach particularly high levels in female teenagers aged 15 and 19, while those behaviours have increased significantly for girls aged 10 to 14 in the last decade, now reaching nearly three times the levels of 2011;

THAT it underline that suicide is a major public health issue in Québec;

THAT it recognize the crucial role played by health and social services network employees, by suicide prevention centres and by community organizations who support people in distress, concerned friends and family members and bereaved people;

THAT it recall the importance of working together in order to raise awareness and mobilize the entire population around the issues related to suicide;

THAT it recognize the national strategy and all suicide prevention initiatives as essential in the fight against this scourge;

THAT, lastly, it commit to continue and strengthen actions to prevent suicide and support the renewal of the suicide prevention national strategy.

By leave of the Assembly, a debate arose thereon.

Mr. Benjamin, Third Vice-President, informed the Assembly that he had received two requests for a debate upon adjournment to be held on Thursday, 5 February 2026,

- the first, on a question from Ms. Prass (D'Arcy-McGee) to Ms. Bélanger, Minister of Health, about the CAQ government's inaction with regard to the rising suicide rate among our young people;
- the second, on a question from Ms. Massé (Sainte-Marie–Saint-Jacques) to Ms. Bélanger, Minister of Health, about the case of Lisette Perron.

### **Business Standing in the Name of Members in Opposition**

Ms. Garceau (Robert-Baldwin) moved:

THAT the National Assembly take note of the alarming increase in violence against women in Québec, in particular domestic violence, which is reflected, among other things, in the many femicides already committed since the beginning of 2026 and in the critical overcrowding of women's shelters and external services, whose capacity has been greatly exceeded;

THAT it be alarmed that, last year, SOS violence conjugale received more than 19,000 requests for shelter and that more than one in two women were turned away due to a lack of space and resources and that, in some regions, the refusal rate was nearly 67%;

THAT it note that the actions taken by the Government in recent years have not curbed the increase in violence against women, that this violence continues to increase, and that it is appropriate and necessary to enhance the policy framework in this regard;

THAT, lastly, it demand that the Government urgently table an update to the 2022–2027 government strategy to fight against sexual violence and domestic violence and to rebuild trust, which is based in particular on predictability of funding for shelters and support services, increased shelter capacity and improved prevention, early detection and support services, including for women experiencing homelessness.

Mr. Benjamin, Third Vice-President, informed the Assembly of the allocation of speaking time with respect to this limited debate: 10 minutes to the mover of the motion for her reply; 50 minutes to the parliamentary group forming the Governments; 25 minutes 43 seconds to the parliamentary group forming the Official Opposition; 15 minutes 43 seconds to the Second Opposition Group; 8 minutes 34 seconds to the Third Opposition Group; and 10 minutes to the independent Members, subject to a maximum of 1 minute 30 seconds each. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

At the beginning of her address, Ms. Lecours (Lotbinière-Frontenac) moved:

THAT the motion moved by the Member for Robert-Baldwin be amended as follows:

1. By striking out, in the first paragraph, the words “and in the critical overcrowding of women’s shelters and external services, whose capacity has been greatly exceeded”;
2. By replacing, in the second paragraph, the words “be alarmed” by “recognize”;
3. By replacing, in the third paragraph, the words “have not curbed the increase in violence against women, that this violence continues to increase, and that it is appropriate and necessary to enhance the policy framework in this regard” by “have helped many victims of domestic violence, but that there is still more work to do to curb this phenomenon”;
4. By replacing the fourth paragraph with the following: “THAT, lastly, it ask the Government to continue its actions to fight against sexual violence and domestic violence, in particular funding for shelters and supports services, increased shelter capacity and improved prevention, early detection and support services, including for women experiencing homelessness.”.

The motion, as amended, would read as follows:

THAT the National Assembly take note of the alarming increase in violence against women in Québec, in particular domestic violence, which is reflected, among other things, in the many femicides already committed since the beginning of 2026;
