### Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Lemieux (Saint-Jean), together with Mr. Paradis (Jean-Talon), Ms. Blanchette Vézina (Rimouski) and Mr. Carmant (Taillon), moved:

THAT the National Assembly recall that, to be appointed a judge of the Superior Court of Québec or the Québec Court of Appeal, it is a legal requirement to be a member of the Barreau du Québec for at least 10 years;

THAT, in this regard, the Assembly ask the Québec government to commit to always defending this fundamental requirement for the recognition of Québec's distinct legal character.

By leave of the Assembly to set aside Standing Order 185, Mr. Arseneau (Îles-de-la-Madeleine), together with Ms. Maccarone (Westmount–Saint-Louis), Mr. Fontecilla (Laurier-Dorion), Ms. Blanchette Vézina (Rimouski), Mr. Marissal (Rosemont) and Ms. Lakhoyan Olivier (Chomedey), moved:

THAT the National Assembly express its grave concern over the spectacular 149% increase in violent crimes in the Côte-Nord region over the last five years, a situation worsened by conflicts related to organized crime and drug trafficking;

THAT it recognize that the city of Sept-Îles currently has the fastest growing violent crime rate in Québec, which greatly affects the sense of security and quality of life of citizens, including the nearby Indigenous communities of Uashat mak Mani-utenam;

THAT, lastly, it ask the Government to reinforce prevention and intervention measures with youth to combat recruitment by criminal organizations and to bolster support for regional social services and community organizations to address the drug addiction issues that are fueling the criminal market.

### **Business Standing in the Name of Members in Opposition**

Mr. Bérubé (Matane-Matapédia) moved:

THAT the National Assembly denounce the CAQ government's poor record for the Saguenay–Lac-Saint-Jean region after two terms of office.

Ms. Soucy, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; 45 minutes to the parliamentary group forming the Government; 22 minutes 37 seconds to the parliamentary group forming the Official Opposition; 13 minutes 49 seconds to the Second Opposition Group; 18 minutes 34 seconds to the Third Opposition Group; and 10 minutes to the independent Members, subject to a maximum of 1 minute 30 seconds each. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.
