Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 11 February 2026, on the motion moved by Mr. Bérubé (Matane-Matapédia) during Business Standing in the Name of Members in Opposition.

The motion reads as follows:

THAT the National Assembly denounce the CAQ government's poor record for the Saguenay–Lac-Saint-Jean region after two terms of office.

THAT the National Assembly recognize that the Québec government has legitimacy to determine its immigration levels and decide on the selection criteria for permanent immigration without being influenced by federal government decisions;

THAT it recall that the imminent end of several thousand work permits is causing serious concerns among the population of non-permanent residents as well as our entrepreneurs, in particular in the regions;

THAT, lastly, it ask the federal government to renew the work permits of foreign workers by aligning with the Québec government, in order to protect our industries, our regional economy and our essential services.
