Insert the following paragraph at the end of proposed section 4.3:

State laicity also requires that every person has the right to parliamentary, government and judicial institutions and to public services that are lay institutions and services, to the extent provided for by law."

SECTION 21 (section 78.1 of the Act respecting private education)

In the first paragraph of proposed section 78.1:

1. Strike out “, or whose provision of childcare services,”.
2. Replace “segregation, in particular on the basis of religious criteria,” by “segregation on the basis of religious criteria”.

SECTION 6 **(section 8 of the Act respecting the laicity of the State)**

Insert at the end of the last proposed paragraph:

(3) to persons going to or present in a place under the authority of a body referred to in paragraph 7 or 12.1 of Schedule I, except a school service centre, leased according to the conditions determined by government regulation.

SECTION 12.1 (section 15 of the Act respecting the laicity of the State)

Insert after section 12:

12.1. Section 15 of the Act is replaced by the following section:

“15. Where the prohibition on wearing religious symbols applies to a person who is not a personnel member of the body, the prohibition is deemed to be an integral part of the contract under which the person acts.”

SECTION 14 **(section 17.1 of the Act respecting the laicity of the State)**

Replace proposed section 17.1 by:

"17.1. An institution or body referred to in section 3 that, in providing food services, offers a diet based on a religious precept or a tradition must also offer an equivalent diet that is not based on such a precept or tradition.

SECTION 16 (section 31.2 of the Act respecting the laicity of the State)

Insert after proposed section 31.1:

“31.2. Religious practice is permitted in the following immovables:

- (1) chapelle Loyola, situated in the territory of Concordia University;
- (2) chapelle Marie-Guyart, situated in the territory of Université Laval;
- (3) Birks Heritage Chapel, situated in the territory of McGill University; and
- (4) St. Mark's Chapel, situated in the territory of Bishop's University.”

AN ACT RESPECTING THE REINFORCEMENT OF LAICITY IN QUÉBEC

SECTION 20 (Schedule II to the Act respecting the laicity of the State)

1. Replace “are providing” in proposed paragraph 13 by “regularly provide”.
2. Insert after proposed paragraph 15:

“(16) persons who provide services in a facility under the authority of a childcare centre or subsidized day care centre governed by the Educational Childcare Act (chapter S-4.1.1), when they are in the facility during the provision of childcare services;

“(17) persons when they are providing services to children in a facility under the authority of a childcare centre or subsidized day care centre governed by the Educational Childcare Act (chapter S-4.1.1);

“(18) the National Director of Youth Protection as well as directors of youth protection and persons the latter authorize to perform their duties under section 32 of the Youth Protection Act (chapter P-34.1); and

“(19) personnel members of Santé Québec who predominantly provide health services or social services, in a rehabilitation centre for young persons with adjustment problems, to a person who is the subject of a detention, custody or supervision measure under the Youth Criminal Justice Act (S.C. 2002, c. 1).”

SECTION 15 (section 31 of the Act respecting the laicity of the State)

In paragraph 2:

1. Replace "paragraph 12 or 13" in proposed paragraph 7 by "any of paragraphs 12, 13, 16 and 17".

2. Insert after proposed paragraph 9:

"(10) to persons referred to in paragraph 18 or 19 of Schedule II on 25 February 2026, for as long as they exercise the same function within the same organization."
