### Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Leduc (Hochelaga-Maisonneuve), together with Mr. Laframboise (Blainville), Ms. McGraw (Notre-Dame-de-Grâce), Ms. Gentilcore (Terrebonne) and Mr. Marissal (Rosemont), moved:

THAT the National Assembly pay tribute to Jean Dorion, sociologist, early separatist, activist and former Member for the Bloc Québécois, who passed away on 23 January 2026;

THAT it underline his unwavering commitment to Québec, in particular as president of the Société Saint-Jean-Baptiste de Montréal, where he defended the French language, created the Prix du Mérite en histoire award for fourth-year high school students who achieved an average of 95% or higher in History, revived the National Holiday parade, and contributed to the vitality of a national movement rooted in civil society;

THAT it recall that his career was guided by a deep-rooted belief in sovereignty based on democracy, culture and dialogue, and that he successfully defended an inclusive vision of Québec identity, in particular through the publication of his book “Inclure : quelle laïcité pour le Québec?”;

THAT it express its sincere condolences to his wife, his five children, his loved ones, and all those who stood with him for a free, fair, and open Québec.

By leave of the Assembly to set aside Standing Order 185, Mr. Boissonneault (Arthabaska), together with Mr. Zanetti (Jean-Lesage), moved:

THAT the National Assembly express its deep concern about the federal government's management of the IT projects Phoenix, ArriveCAN and Cúram;

THAT it note that the Phoenix project, initially estimated at a \$309 million budget, cost \$5.5 billion, that the ArriveCAN project, initially estimated at a \$80,000 budget, cost \$60 million, and that the Cúram project, initially estimated at a \$1.75 billion budget, cost \$6.6 billion;

THAT it recall that the federal government's considerable cost overruns for digital projects are a waste of the taxes paid by Québec taxpayers;

THAT, accordingly, it ask the federal government to begin a public and independent inquiry on federal IT contracts.

THAT the National Assembly of Québec recall that, for the last four years, Russia's invasion of Ukraine has had devastating humanitarian and material consequences;

THAT it reaffirm its unreserved solidarity with the Ukrainian people and Quebecers of Ukrainian origin;

THAT it applaud the admirable resilience of the Ukrainian people;

THAT it reiterate the importance of continuing international efforts to assist Ukraine, in particular with respect to its defence and reconstruction;

THAT it reaffirm its support for respect for Ukraine's territorial integrity and for the values of democracy and the rule of law;

THAT it uphold the importance of a diplomatic conclusion to this war in order to achieve a lasting peace, with security guarantees, negotiated by all parties;

THAT, lastly, the National Assembly observe a minute of silence in memory of the victims of the invasion.
