THAT it recognize that femicide is the most extreme expression of violence against women, who also experience physical, psychological and sexual abuse both within and outside of intimate relationships, and that this violence remains a public health and safety issue that requires ongoing attention;

THAT it pay tribute to all the victims of violence against women, to their loved ones and to the families affected by this unacceptable loss;

THAT it applaud the efforts made by the Québec government to implement many of the recommendations resulting from work on domestic violence prevention and support for gender equality, including the implementation of government strategies, investments in projects for equality and honorary awards in recognition of those working to advance the cause;

THAT it recognize, however, that much remains to be done, in particular in the prevention of violence, the protection of women at risk, the ongoing training of frontline workers, and the implementation of key measures to prevent future tragedies;

THAT, lastly, it reaffirm its commitment to work constructively with all bodies concerned — governmental, community, municipal and citizen — to make the safety of women and de facto equality priority objectives, here in Québec and beyond our borders.
