### Deferred Divisions

The Assembly took the divisions, which had been deferred at the sitting of 4 June 2026, on the motions stating a grievance moved during the debate on the Opening Speech and on the motion moved by Ms. Fréchette, Premier, that the Assembly approve the Government's general policy.

THAT the National Assembly severely censure the CAQ government for its lack of concrete results, the weakening of its commitments to Quebecers, and a stale vision that is ill-suited to the challenges of today.
