**SECTION 2 (section 238.1 of the Consumer Protection Act)**

In the first paragraph of proposed section 238.1:

1. Strike out “, or allow such identity or image to be used,”.
2. Insert “or allow or tolerate such use” at the end.

**SECTION 5 (section 318.6 of the Consumer Protection Act)**

Add after proposed section 318.5:

**"318.6.** Any person on whom an order has been imposed by the President and Chief Executive Officer of the Autorité des marchés financiers under section 318.5 may, within 30 days after notification of the order, contest it before the Financial Markets Administrative Tribunal.

The Tribunal shall, in exercising its power to suspend the execution of the contested order, give particular consideration to the interests of consumers."

**SECTION 6.1** (section 352 of the Consumer Protection Act)

Insert after section 6:

**6.1.** Section 352 of the Act is amended by inserting “, except sections 318.5 and 318.6 whose application is under the responsibility of the Minister of Finance” at the end.

**SECTION 6.2 (section 93 of the Act respecting the regulation of the  
financial sector)**

Insert after section 6.1, introduced by amendment:

**6.2.** Section 93 of the Act respecting the regulation of the financial sector (chapter E-6.1) is amended by replacing the first sentence of the first paragraph by the following sentence: "The Tribunal shall exercise the jurisdiction conferred on it by law."
