ORDERS OF THE DAY

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 18, An Act respecting the Compilation of Québec Laws and Regulations.

After debate thereon, the report was concurred in.

Debates on Reports from Committees

The Assembly took into consideration the report from the Committee on Transportation and the Environment, which, on 27 August and on 2 and 3 September 2009, held public hearings within the framework of special consultations with reference to the document entitled "A first list of sustainable development indicators". The report contains 4 recommendations.

Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate. A set time of 12 minutes shall be set aside for the Second Opposition Group and 5 minutes shall be allotted to the independent Member, while the parliamentary group forming the Government and the parliamentary group forming the Official Opposition shall share equally the rest of the time allotted for this debate. Within this framework, any time not used by the independent Member or by the Members of the Second Opposition Group shall be redistributed equally among the parliamentary group forming the Government and the parliamentary group forming the Official Opposition. Any time not used by the parliamentary group forming the Government shall go to the parliamentary group forming the Official Opposition and vice versa. Lastly, individual addresses shall not be limited.

The debate arose thereon.

The debate expired and, pursuant to Standing Order 95, no question was put.

At 4.56 o'clock p.m., at the request of Mr. Dutil, Minister of Revenue, Mr. Chagnon, Second Vice-President, suspended the proceedings until 6.00 o'clock p.m.
