Moment of reflection

RULING FROM THE CHAIR

This request for an urgent debate is receivable. The request concerns a definite and important matter involving the responsibility of the Assembly. There is no doubt of the urgency of holding a debate on this subject. Indeed, the agreement comes into force today, yet the National Assembly has not thus far had an opportunity to debate it.

THAT the National Assembly of Québec takes note of the consensus expressed by the partners in the world of education, in particular parents, teachers, and their representatives as well as the school boards, and calls for the withdrawal of the draft regulation to amend the pedagogical system and the school calendar.

Report Stage

The Assembly took into consideration the report from the Committee on Planning and the Public Domain on its clause-by-clause consideration of Bill 76, An Act to amend various legislative provisions principally with regard to the awarding process for contracts made by municipal bodies.

After debate thereon, the report was concurred in.

Urgent Debates

Before entering upon the urgent debate on the Agreement between the Government of Canada and the Government of the United States of America on Government Procurement, Mr. Chagnon, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings during this limited debate: five minutes shall be allotted to the Member for Mercier; three minutes 30 seconds shall be allotted to the other two independent Members; eight minutes 30 seconds shall be allotted to Members from the Second Opposition Group; the rest of the time available, being 51 minutes 30 seconds for each of the two groups, shall be divided equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition.
