Introduction of Bills

Mrs. Thériault, Minister for Social Services, moved that leave be granted to introduce the following Bill:

An Act respecting the adoption of Haitian children who arrived in Québec between 24 January and 16 February in the aftermath of the 12 January 2010 earthquake

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. James, Minister of Families, together with Mr. Girard (Gouin), Mrs. Roy (Lotbinière), Mr. Picard (Chutes-de-la-Chaudière), Mr. Caire (La Peltrie), and Mr. Khadir (Mercier), moved:

THAT the National Assembly salute Québec Family Week, which is being observed from 10 to 16 May 2010 under the theme: *Pour un Québec famille ... partageons nous coups de coeur* (For a family-friendly Québec, let's share our heartthrobs).

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mrs. Hivon (Joliette), together with Mrs. Weil, Minister of Justice, Mrs. Thériault, Minister for Social Services, Mr. Gauvreau (Groulx), Mrs. Roy (Lotbinière), Mr. Picard (Chutes-de-la-Chaudière), Mr. Caire (La Peltrie), and Mr. Khadir (Mercier), moved:

THAT the National Assembly asks the federal Government to make the amendments to Bill C-4 which are necessary in order that the Québec philosophy of rehabilitation and social reintegration, which prevails with regard to penal justice for adolescents, be preserved;

THAT the National Assembly reaffirms the validity and the importance of maintaining the Québec model for treating young offenders, which has been unanimously accepted in Québec and has enabled Québec to achieve one of the lowest rates of juvenile criminality in America during the past 25 years.

By leave of the Assembly, the question was put on the motion; a recorded division was thereupon demanded.

At the request of Mr. Gautrin, Deputy Government House Leader, the division was deferred until the Routine Proceedings on the next sitting day.

Mr. Bédard, Official Opposition House Leader, asked Mrs. Houda-Pepin, First Vice-President, for a directive concerning the application of Standing Order 223 to motions moved under Motions without Notice.

At 11.39 o'clock a.m., after having heard arguments from all sides, Mrs. Houda-Pepin, First Vice-President, took the matter under advisement, for which purpose she suspended the proceedings during pleasure.

The proceedings resumed at 12.10 o'clock p.m.

Mrs. Houda-Pepin, First Vice-President, ruled as follows on the request for a directive by Mr. Bédard, Official Opposition House Leader:

RULING FROM THE CHAIR

It is clear from Standing Order 223 that all divisions may be deferred, save those on motions for adjournment or for the previous question. All other divisions may be deferred, and motions without notice are not exempted from this rule. The division on the motion moved by the Member for Joliette may therefore be deferred until the Routine Proceedings on the next sitting day, that is to say on Tuesday 18 May next.

The division having been deferred until the next sitting day, as provided in Standing Order 223, it must be held on 18 May and may in no event be further deferred.

By leave of the Assembly to set aside Standing Order 84.1, and pursuant to Standing Order 146, Mr. Gautrin, Deputy Government House Leader, moved:

THAT the Committee on Culture and Education, during its consideration of Bill 86, An Act to defer the November 2011 general school election, hold public hearings within the framework of special consultations on 25 May 2010 and that, for this purpose, it hear the following bodies:

- Union des municipalités du Québec
- Fédération québécoise des municipalités
- Fédération des commissions scolaires
- The Chief Electoral Officer of Québec
- English School Boards Association

THAT a period of 20 minutes be set aside for preliminary remarks, to be shared equally between the parliamentary group forming the Government and the Members sitting in opposition;

THAT the presentation by each body may last for up to ten minutes and the exchange with the members of the committee may last for up to 50 minutes, to be shared equally between the parliamentary group forming the Government and the Members sitting in opposition;

THAT a period of 20 minutes be set aside for closing remarks, to be shared equally between the parliamentary group forming the Government and the Members sitting in opposition;

THAT the Minister of Education, Recreation and Sports be a member of the said committee throughout the execution of this order.

By leave of the Assembly, the motion was carried.

Notices of Proceedings in Committees

Mr. Gautrin, Deputy Government House Leader, convened the following Committees:

- the Committee on Agriculture, Fisheries, Energy and Natural Resources, to continue its public hearings within the framework of a general consultation on Bill 79, An Act to amend the Mining Act;

- the Committee on Transportation and the Environment, to continue its clause-by-clause consideration of Bill 90, An Act concerning Parc national du Mont-Orford.

— the Committee on Institutions, to begin public hearings within the framework of a general consultation on Bill 94, An Act to establish guidelines governing accommodation requests within the Administration and certain institutions.

Mrs. Houda-Pepin, First Vice-President, gave the following notice:

— the Committee on Culture and Education will hold a deliberative meeting for the purpose of organizing visits to the regions within the framework of its order of initiative on school dropouts in Québec.

ORDERS OF THE DAY

Government Bills

Passage in Principle

Mrs. Beauchamp, Minister of Sustainable Development, Environment and Parks, moved, —That Bill 88, An Act to amend the Environment Quality Act as regards residual materials management and to amend the Regulation respecting compensation for municipal services provided to recover and reclaim residual materials, do now pass in principle.

A debate arose thereon.

At 12.57 o'clock p.m., Mrs. Houda-Pepin, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.00 o'clock p.m.

Passage in Principle

The Assembly continued the debate on the motion by Mrs. Beauchamp, Minister of Sustainable Development, Environment and Parks, —That Bill 88, An Act to amend the Environment Quality Act as regards residual materials management and to amend the Regulation respecting compensation for municipal services provided to recover and reclaim residual materials, do now pass in principle.

The debate being concluded, the motion was carried and Bill 88 was accordingly passed in principle.

Mr. Gautrin, Deputy Government House Leader, moved that Bill 88 be referred for clause-by-clause consideration to the Committee on Transportation and the Environment.

The motion was carried.

Debates on Reports from Committees

The Assembly took into consideration the report from the Committee on Transportation and the Environment, which, on 15 February 2010, examined the orientations, activities, and management of the Bureau d'audiences publiques sur l'environnement. This report contains four recommendations.

After a meeting with the House leaders, Mr. Chagnon, Second Vice-President, announced the allocation of speaking time for the proceedings with respect to this limited debate: five minutes shall be set aside for the Member for Mercier; three minutes 30 seconds shall be set aside for the other independent Members; eight minutes 30 seconds shall be set aside for the Members from the Second Opposition Group; the remaining time allotted for this debate will be shared equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition. Within this framework any time not used by the independent Members or the Members from the Second Opposition Group shall be redistributed equally between the

parliamentary group forming the Government and the parliamentary group forming the Official Opposition; and any time not used by the parliamentary group forming the Government shall be attributed to the parliamentary group forming the Official Opposition, and vice versa. Lastly, individual speeches will not otherwise be limited.

A debate arose thereon.

The debate expired and, pursuant to Standing Order 95, no question was put.

Private Bills

Passage in Principle

By leave of the Assembly to set aside Standing Order 268, Mr. Pelletier (Rimouski) moved the passage in principle of Private Bill 216, An Act respecting Ville de Rimouski.

After debate thereon, the motion was carried, and Private Bill 216 was accordingly passed in principle.
