Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 101, An Act to amend the Act respecting the Pension Plan of Management Personnel and other legislation establishing pension plans in the public sector.

After debate thereon, the report was concurred in.

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 83, An Act to provide a framework for mandatory state financing of certain legal services.

Mr. Gendron, Third Vice-President, gave the following directive on the preservation of order and decorum in the Assembly:

DIRECTIVE FROM THE CHAIR

During the sitting strangers admitted to the galleries shall remain seated and be silent, and they shall refrain from making any sign of approval or disapproval. In the current context, so as not to disrupt the orderly conduct of the proceedings, the Chair asks every stranger who may be wearing some distinctive sign to remove it.

Business Standing in the Name of Members in Opposition

Mrs. Marois, Leader of the Official Opposition, moved:

THAT the National Assembly of Québec demand the holding of an independent public inquiry into all of the allegations relating to the construction industry, to the granting of government contracts, permits, and subsidies, as well as into the financing of political parties.

Following a meeting with the House leaders, Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this motion: ten minutes shall be allotted to the mover of the motion for her reply; five minutes shall be allotted to the Member for Mercier; three minutes shall be allotted to each of the other two independent Members; seven minutes 45 seconds shall be allotted to the Second Opposition Group; 47 minutes shall be allotted to the parliamentary group forming the Government; and 44 minutes 15 seconds shall be allotted to the parliamentary group forming the Official Opposition.
