## Information on the Proceedings of the Assembly

#### DIRECTIVE FROM THE CHAIR

The organization of committee proceedings comes within the competence of the chairman of the Committee. The latter has sole authority to chair this Committee. The President of the National Assembly cannot interfere in the organization of the proceedings of a parliamentary committee and has no say in such matter.

#### **Government Bills**

Passage in Principle

By leave of the Assembly to set aside Standing Order 237, Mr. Landry, Minister of Agriculture, Fisheries and Food, moved, —That Bill 114, An Act to amend the Act respecting the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation and other legislative provisions with respect to the horse racing industry, do now pass in principle.

And debate arising;

On motion by Mr. Boisclair, Deputy Government House Leader, the debate was adjourned.

Passage

Mr. Bégin, Minister of Justice, moved the passage of Bill 92, An Act to amend the Code of Penal Procedure and other legislative provisions (*modified title*).

After debate thereon, the motion was carried and, accordingly, Bill 92 was passed.

Mrs. Blackburn, Minister of Income Security, moved the passage of Bill 106, An Act to amend the Act respecting the Québec Pension Plan and the Automobile Insurance Act.

After debate thereon, the motion was carried and, accordingly, Bill 106 was passed.

Passage in Principle

Resuming the debate on the motion by Mr. Landry, Minister of Agriculture, Fisheries and Food, —That Bill 114, An Act to amend the Act respecting the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation and other legislative provisions with respect to the horse racing industry, do now pass in principle;

The debate being concluded, the motion was carried and Bill 114 was accordingly passed in principle.

After debate thereon, the motion was carried and Bill 110 was accordingly passed in principle.

On motion by Mr. Boisclair, Deputy Government House Leader, Bill 110 was referred for clause-by-clause consideration to the Committee of the Whole.

On motion by Mr. Boisclair, Deputy Government House Leader, the Assembly then resolved itself into a Committee of the Whole for the clause-by-clause consideration of Bill 110.

The said Bill was amended and then carried by the Committee.

Bill 110 was thereupon reported to the Assembly, which concurred in the report from the Committee of the Whole.

Passage

Mrs. Marois, Minister of Revenue, moved, —That Bill 108, An Act to amend the Taxation Act, the Act respecting the Québec sales tax and other legislative provisions, do now pass in principle.
After debate thereon, the motion was carried on division and Bill 108 was accordingly passed in principle.
On motion by Mr. Boisclair, Deputy Government House Leader, Bill 108 was referred for clause-by-clause consideration to the Committee on the Budget and Administration.
Mrs. Marois, Minister of Finance, moved, –That Bill 109, An Act to amend the Act respecting the legal publicity of sole proprietorships, partnerships and legal persons, do now pass in principle.

After debate thereon, the motion was carried and Bill 109 was accordingly passed in principle.
