Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Complaints of Breach of Privilege or Contempt and Personal Explanations

By leave of the Assembly to set aside Standing Orders 53, 71 and 72, Mr. Morin (Dubuc) gave explanations regarding certain comments he had made to a journalist, comments which were reported by Mrs. Gagnon-Tremblay (Saint-François) during Question Period of the current sitting.

Following these explanations, Mrs. Gagnon-Tremblay having begged leave to speak, Mr. Lefebvre, Deputy Opposition House Leader, requested a directive from the President on the application of Standing Order 213 within the context of personal explanations.

After a brief suspension of the proceedings, Mr. President gave the following directive regarding the question raised by Mr. Lefebvre:

DIRECTIVE FROM THE CHAIR

Personal explanations do not give rise to the application of Standing Order 213, which stipulates that any Member may, immediately another Member has finished speaking and with his consent, ask him a question. Such question falls within the framework of a debate, since Standing Order 213 comes under the chapter pertaining to debates.

Motions Without Notice

Mr. Marsan (Robert-Baldwin) moved a motion concerning the report of the expert committee on drug insurance; this motion could not be debated for want of unanimous consent.
