

## **Introduction of Bills**

Mr. President communicated to the Assembly and then laid upon the Table the report from the Law Clerk on the following Private Bill:

**ROUTINE PROCEEDINGS** 

225 An Act respecting the Charter of the city of Hull X This Bill may be introduced in the Assembly and it may receive final passage before the twenty-third day of June 1996.

### **Oral Questions and Answers**

#### **Deferred Divisions**

The Assembly took the division, which had been deferred during Business Standing in the Name of Members in Opposition at the sitting of 1 May 1996, on the motion moved by Mr. Gautrin (Verdun). The motion reads as follows:

THAT the National Assembly denounce the inconsistency and improvisation on the part of the Government regarding the cutbacks imposed on the education sector that will inevitably affect the quality of teaching and services to students, increase student dues and cause a rise in school taxes.

#### **Business Having Precedence**

Estimates of Expenditure

The Assembly began a limited debate on the reports of the Committees that had considered the Estimates of Expenditure for the 1996-97 fiscal year.

Before the debate began, Mr. President, following a meeting with the House Leaders of the parliamentary groups, announced the allocation of speaking time for the proceedings with respect to this limited debate: Five minutes shall be set aside for each of the independent Members; the two parliamentary groups shall share equally the rest of the time not taken by the independent Members, but individual addresses shall not otherwise be limited.

And debate arising on the reports of the Committees that had considered the Estimates of Expenditure for the 1996-97 fiscal year;

The debate being concluded, Mr. Pinard, Vice-President, informed the Assembly that, pursuant to Standing Order 288, the question on these reports would be put after the Assembly had decided the question on the motion moved by the Minister of Finance at the end of the Budget Speech.

#### **Government Bills**

Passage in Principle

Mr. Bégin, Minister of Justice, moved, —That Bill 7, An Act to amend the Code of Civil Procedure, the Act respecting the Régie du logement, the Jurors Act and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 7 was accordingly passed in principle.

On motion by Mrs. Caron, Deputy Government House Leader, Bill 7 was referred for clause-by-clause consideration to the Committee on Institutions.

At 5.58 o'clock p.m., Mr. Pinard, Vice-President, having left the Chair, the proceedings were suspended until 8.00 o'clock p.m.

Passage in Principle

Mr. Bégin, Minister of Justice, moved, —That Bill 130, An Act respecting administrative justice, do now pass in principle.

After debate thereon, the motion was carried and Bill 130 was accordingly passed in principle.

On motion by Mr. Bélanger, Government House Leader, Bill 130 was referred for clause-byclause consideration to the Committee on Institutions.

Mr. Bégin, Minister of Justice, moved, —That Bill 133, An Act to amend the Charter of human rights and freedoms and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 133 was accordingly passed in principle.

On motion by Mr. Bélanger, Government House Leader, Bill 133 was referred for clause-byclause consideration to the Committee on Institutions.

#### **Debates Upon Adjournment**

At 9.43 o'clock p.m., by leave of the Assembly to set aside Standing Order 309, the Assembly held a debate upon adjournment between Mr. Cusano (Viau) and Mr. Rochon, Minister of Health and Social Services, concerning the outflow of transplant specialists from Québec.

By leave of the Assembly to set aside Standing Order 59, Mr. Cusano (Viau) tabled the following:
